To reappropriate moneys from the various appropriations within the General Fund to the various appropriations within said Fund for the current operations of the several governmental departments, as herein specified, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the following sums be reappropriated from the various appropriations within the General Fund to the appropriations within said fund hereinafter set forth, for the current operation of the various departments herein shown, to-wit:

- (a) \$150.00 from 1A4 to 1C2 in the General Fund.
- (b) \$200.00 from 1A5 to 1C2 in the General Fund.
- (c) \$ 75.00 from 1B4 to 1C2 in the General Fund.
- (d) \$100.00 from 1B5 to 1C2 in the General Fund.
- (e) \$100.00 from 1B6 to 1C2 in the General Fund.
- (f) \$100.00 from 1F5 to 1C2 in the General Fund.
- (g) \$200.00 from 1F7 to 1C4 in the General Fund.
- (h) \$100.00 from 1H5 to 1C4 in the General Fund.
- (i) \$800.00 from 1F7 to 1C2 in the General Fund.
- (j) \$200.00 from 1D3 to 1C2 in the General Fund.
- (k) \$1400.00 from 1D2 to 1C2 in the General Fund.
- (l) \$500.00 from 1E3 to 1C2 in the General Fund.
- (m) \$300.00 from 1E4 to 1C2 in the General Fund.
- (n) \$100.00 from 1N1 to 1C2 in the General Fund.
- (o) \$900.00 from 1P1 to 1C2 in the General Fund.
- (p) \$250.00 from 1N3 to 1M1 in the General Fund.
- (q) \$500.00 from 1O1 to 1M1 in the General Fund.
- (r) \$325.00 from 1M4 to 1M3 in the General Fund.
- (s) \$345.00 from 1M4 to 1M5 in the General Fund.
- (t) \$190.00 from 1M2 to 1M5 in the General Fund.
- (u) \$125.00 from 1I7 to 1M5 in the General Fund.
- (v) \$140.00 from 1E2 to 1E1 in the General Fund.
- (w) \$ 75.00 from 1E5 to 1E1 in the General Fund.
- (x) \$ 50.00 from 1E6 to 1E1 in the General Fund.
- (y) \$200.00 from 1Z3 to 1Z4 in the General Fund.

(z) \$350.00 from 1Z5 to 1Z6 in the General Fund.

1(a) \$100.00 from 1Z5 to 1Z7 in the General Fund.

Section 2. That the following sums be reappropriated from the various appropriations within the Safety Fund to the appropriations herein set forth within said Safety Fund for the current operation of the Safety Department.

(a) \$200.00 from 2C6 to 2C5 in the Safety Fund.

(b) \$100.00 from 2C1 to 2C3 in the Safety Fund.

(c) \$2000.00 from 2C1 to 2C8 in the Safety Fund.

(d) \$ 25.00 from 2C1 to 2C4 in the Safety Fund.

Section 3. That the following sums be reappropriated from the various appropriations within the Health Fund to the appropriations herein set forth within said Health Fund for the current operation of the Health Department.

(a) \$100.00 from 3A3 to 3A4 in the Health Fund.

Section 4. That the following sums be reappropriated from the various appropriations within the Service Fund to the appropriations herein set forth within said Service Fund for the current operation of the Service Department.

(a) \$1000.00 from 4C9 to 4C7 in the Service Fund.

(b) \$1000.00 from 4C9 to 4Y7 in the Service Fund.

(c) \$ 200.00 from 4L1 to 4Y7 in the Service Fund.

(d) \$ 600.00 from 4L1 to 4C5 in the Service Fund.

Section 5. That the following sums be reappropriated from the various appropriations within the Street Construction, Maintenance and Repair Fund to the appropriations herein set forth within said Fund for the current operation of said Street Repair Department.

(a) \$100.00 from 12A1 to 12A11 in the Street Construction, Maint. & Repair Fund.

(b) \$3800.00 from 12A6 to 12A14 in the Street Construction, Maint. & Repair Fund.

(c) \$600.00 from 12A1 to 12C9 in the Street Construction, Maint. & Repair Fund.

Section 6. That the following sums be reappropriated from the various appropriations within the Water Fund to the appropriations herein set forth within said Water Fund for the current operation of the Water Department.

(a) \$150.00 from 6A1 to 6A3 in the Water Fund.

(b) \$100.00 from 6A1 to 6A6 in the Water Fund.

Section 7. This ordinance is an emergency measure, necessary for the immediate preservation of the public peace, health and safety in the daily operation of various City Departments, and the same shall go into full force and adoption upon the approval thereof.
