

ORDINANCE NO. 45 -69

To reappropriate moneys from the various appropriations within the General Fund to the various appropriations within said Fund for the current operations of the several governmental departments, as herein specified, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the following sums be reappropriated from the various appropriations within the General Fund to the appropriations within said fund hereinafter set forth, for the current operation of the various departments herein shown, to-wit:

- (a) \$ 30.00 from 1B5 to 1B4 in the General Fund
- (b) \$ 10.00 from 1C2 to 1C3 in the General Fund
- (c) \$ 125.00 from 1C2 to 1C4 in the General Fund
- (d) \$ 10.00 from 1C2 to 1C5 in the General Fund
- (e) \$ 225.00 from 1C2 to 1F2 in the General Fund
- (f) \$ 125.00 from 1C2 to 1F5 in the General Fund
- (g) \$2000.00 from 1C2 to 1E1 in the General Fund
- (h) \$ 500.00 from 1E3 to 1E2 in the General Fund
- (i) \$ 125.00 from 1E4 to 1E2 in the General Fund
- (j) \$3100.00 from 1M1 to 1E6 in the General Fund
- (k) \$1700.00 from 1M1 to 1M2 in the General Fund
- (l) \$ 25.00 from 1M1 to 1M4 in the General Fund
- (m) \$2000.00 from 1M1 to 1M5 in the General Fund
- (n) \$ 10.00 from 1H5 to 1I7 in the General Fund
- (o) \$ 200.00 from 1Z2 to 1Z4 in the General Fund

Section 2. That the following sums be reappropriated from the various appropriations within the Safety Fund to the appropriations herein set forth within said Safety Fund for the Current operation of the Safety Department.

- (a) \$ 600.00 from 2C1 to 2C4 in the Safety Fund
- (b) \$2500.00 from 2C1 to 2C7 in the Safety Fund
- (c) \$ 600.00 from 2C1 to 2C10 in the Safety Fund

Section 3. That the following sums be reappropriated from the various appropriations within the Health Fund to the appropriations herein set forth within said Health Fund for the current operation of the Health Department.

(a) \$ 350.00 from 3A3 to 3B2 in the Health Fund

Section 4. That the following sums be reappropriated from the various appropriations within the Service Fund to the appropriations herein set forth within said Service Fund for the current operation of the Service Department.

(a) \$ 100.00 from 4C7 to 4C5 in the Service Fund

(b) \$ 50.00 from 4O9 to 4O8 in the Service Fund

(c) \$2000.00 from 4P7 to 4P6 in the Service Fund

(d) \$ 125.00 from 4P7 to 4P8 in the Service Fund

(e) \$ 50.00 from 15B3 to 15B4 in the Service Fund

Section 5. That the following sums be reappropriated from the various appropriations within the Street Construction, Maintenance and Repair Fund to the appropriations herein set forth within said Fund for the current operation of said Street Repair Department.

(a) \$ 25.00 from 12A1 to 12A6 in the Street Construction, Maint. & Repair Fund

(b) \$ 35.00 from 12A1 to 12A8 in the Street Construction, Maint. & Repair Fund

Section 6. That the following sums be reappropriated from the various appropriations within the Water Fund to the appropriations herein set forth within said Water Fund for the current operation of the Water Department.

(a) \$ 600.00 from 6A1 to 6F1 in the Water Fund

(b) \$ 310.00 from 6A3 to 6F1 in the Water Fund

(c) \$ 100.00 from 6A1 to X6H22 in the Water Fund

(d) \$ 225.00 from 6B1 to X6J23 in the Water Fund

Section 7. That the following sums be reappropriated from the various appropriations within the Sewer Fund to the appropriations herein set forth within said Sewer Fund for the current operation of the Sewer Department.

(a) \$ 150.00 from 4T4 to 4T5 in the Sewer Fund

Section 8. This ordinance is an emergency measure, necessary for the immediate preservation of the public peace, health and safety in the daily operation of various City Departments, and the same shall go into full force and adoption upon approval thereof.
