

RESOLUTION NO. 1 - 70  
TO AUTHORIZE RENEWAL OF ALLEY IMPROVEMENT NOTE

WHEREAS, Ordinance No. 22-69 passed by the Bexley City Council on May 27, 1969, authorized the issuance and sale of notes in anticipation of the levy and collection of special assessments, and in anticipation of the issuance of bonds and,

WHEREAS, construction of said alleys is proceeding and nearing completion and,

WHEREAS, weather conditions prevented the completion of said alley improvements on or before December 1, 1969, the maturity date of the note authorized in Ordinance No. 22-69 and,

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That it is hereby determined to be necessary to renew the note for the aforementioned improvements in the City of Bexley, Ohio, in the principal sum of \$100,000.00 issued in anticipation of the levy and collection of special assessments.

Section 2. Said anticipatory note shall be dated December 1, 1969, and shall bear interest at the rate of 6 1/4% per annum, payable annually, and shall mature on the 30th day of November, 1970.

Section 3. The City Auditor and Mayor are authorized to issue said renewal note and to sign the same. Said note shall be payable at The Ohio National Bank, and may be called by the City of Bexley, Ohio, at any time prior to maturity date.

Section 4. This ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of said City, and for the further reason related in the preamble hereof, this ordinance shall be in full force and effect from and immediately after its passage and approval by the Mayor.






