

ORDINANCE NO. 23 -70

Providing for an increase in the salaries of certain appointed officials and employees, changing certain titles as provided, and declaring an emergency.

WHEREAS, by reason of the present economic conditions, Council deems it expedient and proper to provide for an increase in salaries of certain appointed officials and employees of the city, NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1. That the position of Superintendent of Streets, Building and Service is hereby abolished as of June 1, 1970 and in its place there is created the position of Assistant Service Director and Superintendent of Building Department.

Section 2. That the position of Assistant to Superintendent of Street, Building and Service is hereby abolished as of June 1, 1970 and in its place there is created the position of Superintendent of Streets and Service.

Section 3. That effective as of June 1, 1970 and until further action of Council, the yearly salaries of the following appointive officials and employees shall be not more than the following amounts, and shall be paid every two weeks:

Section 4. That Blue Cross comprehensive coverage and Blue Shield preferred coverage shall be furnished free of charge to all the above employees, their spouses and unmarried children under 19 years of age residing at home, plus \$1,000.00 life insurance on each employee.

Section 5. That this ordinance is an emergency measure necessary in the daily operation of the various departments of the city government, and for the preservation of the public peace, health and safety of the city, and shall be in full force and effect on its passage and approval by the Mayor.
