Section 2. That the owners of all lots and lands bounding and abutting upon the proposed sidewalks shall repair in accordance with plans and specifications as set forth in Ordinance No. 11-48. The portion of such sidewalks abutting on their respective properties within a period of forty-five (45) days after service of notice of this resolution; and, if such repair shall not be completed within such period of forty-five (45) days, then this Council shall have the same done and the entire cost thereof shall be assessed upon the property by law with penalty and interest as provided by law.

Section 3. That the Clerk of this Council is directed to cause a written notice of passage of this resolution to be served as required by law.

Section 4. The plans, specifications and estimate of cost of said repair as heretofore filed are hereby approved.

Section 5. This resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety and for the further reason that the immediate repair of such sidewalks is urgently required to permit safe passage by persons using said sidewalks and to eliminate existing hazards to pedestrians; wherefore this resolution shall be in full force and effect in and immediately after passage.

**RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR**

(CITY COUNCIL)

Rev. Code, Secs. 5705.34, 5705.35

The Council of the City of BEXLEY, Franklin County, Ohio, met in regular session on the 28th day of September, 1971, at the office of Bexley Municipal Building with the following members present:

Mr. Shawan moved the adoption of the following Resolution:

WHEREAS, This Council in accordance with the provisions of law has previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1st, 1972; and

WHEREAS, The Budget Commission of Franklin County, Ohio, has certified its action thereon to this Council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council, and what part thereof is without, and what part within the ten mill tax limitation; therefore be it

RESOLVED, By the Council of the City of Bexley, Franklin County, Ohio, that the amounts and rates, as determined by the Budget Commission in its certification, be and the same are hereby accepted; and be it further

RESOLVED, That there be and is hereby levied on the tax duplicate of said City the rate of each tax necessary to be levied within and without the ten mill limitation as follows:

**SCHEDULE A**
