

RESOLUTION NO. 1-74
RESOLUTION DECLARING IT NECESSARY TO LEVY A TAX
IN EXCESS OF THE TEN MILL LIMITATION

The Council of the City of Bexley, Franklin County, Ohio met in regular session on the 21st day of January, 1974 at the Bexley City Hall, with the following members present:

Mr. David H. Madison, President; Messrs. Richard Addison, Norman Divine, Thomas Elsass, John Offenberg, Geoffrey Stern and Mrs. Carolyn Wood.

Mr. Addison moved the adoption of the following Resolution:

WHEREAS, the amount of taxes which may be raised within the ten mill limitation by levies on the current tax duplicate will be insufficient to provide an adequate amount for the necessary requirements of said City of Bexley, Franklin County, Ohio; therefore be it

RESOLVED, by the Council of the City of Bexley, Franklin County, Ohio, two-thirds of all members elected therein concurring, that it is necessary to levy a tax in excess of the ten mill limitation for the benefit of the City of Bexley for the purpose of current expenses, at a rate not exceeding 3.0 mills for each one dollar of valuation, which amounts to \$0.30 for each one hundred dollars of valuation, for five (5) years and which levy is a renewal of an existing levy of 3.0 mills.

RESOLVED, that the question of levying additional taxes be submitted to the electors of said City of Bexley at the Primary election to be held at the usual voting places within said City of Bexley on the 7th day of May, 1974; and be it further


RESOLVED, that said levy be extended on the tax list of the City of Bexley if a majority of the electors voting thereon vote in favor thereof; and be it further

RESOLVED, that the Clerk of this Bexley City Council be and he is hereby directed to certify a copy of this Resolution to the Board of Elections, Franklin County, Ohio, as provided by law, and notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law.

Mr. Elsass seconded the Resolution and the roll being called upon its adoption, the vote resulted as follows:


