ordinance no. $\frac{4}{-79}$

An Ordinance to make appropriations for capital improvements during the fiscal year ending December 31, 1979.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1: That the following sums be and they are transferred from the unencumbered General Fund to the Recreation Fund and that they then be and are hereby set aside and appropriated from the Recreation Fund:

- (a) \$1500.00 for the improvement of the playschool bathroom;
- (b) \$3000.00 for Jeffrey Park preservation;
- (c) \$4000.00 for playground equipment for Schneider Park.

Section 2: That the following sum be and it is hereby set aside and appropriated from the unencumbered General Fund for use for the Police Department:

(a) \$14,500.00 for the purchase of two (2) new police cruisers; for the purchase of a radio for the Animal Control Van; and for the purchase of one (1) mobile charger.

Section 3: That the following sum be and it is transferred from the unencumbered General Fund to the Street Maintenance and Repair Fund and that it then be and it is hereby set aside and appropriated from the Street Maintenance and Repair Fund:

(a) \$267,398.00 for the street and alley resurfacing project in middle and north Bexley.

Section 4: That the following sum be and it is transferred from the unencumbered General Fund to the Refuse Fund and that it then be and it is hereby set aside and appropriated from the Refuse Fund:

(a) \$46,000.00 for the purchase of two (2) dump trucks, two (2) satellite collection vehicles, and five (5) mobile radios.

Section 5: That the following sums be and they are hereby set aside and appropriated from the unencumbered General Fund for use for the Service Department:

- (a) \$6000.00 for the purchase of a new riding mower;
- (b) \$500.00 for the purchase of trees and plants for Schneider Park;
- (c) \$1500.00 for the purchase and installation of new overhead lights for the garage;
- (d) \$500.00 for the purchase of a new file cabinet;

(e) \$3000.00 for the purchase and installation of a new underground storage tank and gasoline pump for non-leaded gasoline.

Section 6: That the following sum be and it is hereby set aside and appropriated from the unencumbered Refuse Fund for use for the Service Department:

(a) \$1000.00 for the purchase of two (2) metal dumpsters.

Section 7: That the Mayor and Auditor be, and they hereby are, authorized and directed to enter into contracts for the purchase of the necessary equipment, labor and materials specifically identified in the previoussix (6) sections, the total cost of which shall not exceed the sums so specified and appropriated in each section, and the complete specifications for which have been prepared and are on file in the office of the Mayor.

Section 8: Said contracts shall be entered into with the lowest and best bidder after advertisement according to law.
