

ORDINANCE NO. 15-80

An ordinance to make appropriations for capital improvements during fiscal year ending December 31, 1980.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY,
OHIO:

Section 1: That the following sum be and it is transferred from the unencumbered General Fund to the Street Maintenance and Repair Fund and that it then be and it is hereby set aside and appropriated from the Street Maintenance and Repair Fund:

- (a) \$214,282.00 for the street resurfacing projects, both blacktop overlay and slurry seal.

Section 2: That the following sums be and they are hereby set aside and appropriated from the unencumbered General Fund for use for the Service Department:

- (a) \$42,000.00 for purchase of a platform truck with a fifty (50) foot aerial boom attachment.
- (b) \$22,000.00 for purchase of a tractor equipped with a backhoe attachment and front-end loader with the trade-in of the existing backhoe which is now 15 years old.
- (c) \$1,500.00 for alterations of the Service Department Office.
- (d) \$1,350.00 to purchase a complete dictating and transcribing system for the Service Department Office.

Section 3: That the following sums be and they are hereby set aside and appropriated from the unencumbered General Fund for the use of the department and the purpose indicated:


- (a) \$1,500.00 for the Parks and Forestry Department for the landscape improvements for the Main Street side of the City Hall Building.
- (b) \$1,000.00 for the City Garage for the purchase of maintenance equipment including a new battery charger, tire safety cage and ½-inch impact wrench.
- (c) \$3,300.00 for City Hall for the purchase of a completely new public address system to be installed in Council Chambers.
- (d) \$1,200.00 for the Water Lines Department for the purchase of necessary tools and equipment used in the repair of water mains and lines.


Section 4: That the Mayor and Auditor be and they hereby are, authorized and directed to enter into contracts for the purchase of the necessary equipment, labor, and materials specifically identified in the previous three (3) sections, the total cost of which shall not exceed the sums so specified and appropriated in each section, and the complete specifications for which have been prepared and are on file in the office of the Mayor.

Section 5: Said contracts shall be entered into with the lowest and best bidder after advertisement according to law when competition is so required.


Section 6: That this Ordinance is an emergency measure necessary for the immediate preservation of the public peace, health, and safety, and this Ordinance shall go into effect upon its passage and approval by the Mayor.
