
Section 2. That the following sums should be, and they hereby are, appropriated and set aside from the respective encumbered funds to the accounts designated:


Section 3. That the sum of \$5,000 should be, and it hereby is, transferred from Account No. 01-330-122 to Account No. 01-330-101.


