- " 13-80 To hire special counsel to represent the City of Bexley, the Board of Zoning Appeals, the Zoning Officer, and the individual members of the Board of Zoning Appeals in an appeal rendered by the BZA on October 12, 1978.
- " 14-80 Contract with Gregory S. Lashutka, City Attorney for Columbus, for prosecution of certain cases in the Franklin County Court.
- " 15-80 Capital Improvements ordinance.
- " 16-80 To authorize hiring of expert services in tree pruning and trimming for bird control on Bellwood, Columbus, and Allegheny Avenues.
- " 17-80 To authorize leasing of a new Xerox machine.
- " 18-80 To authorize purchase of portable radios for the Police Department.
- " 19-80 To authorize ODOT to install signal preemptor devices on existing traffic signal controls at certain intersections along E. Broad Street in Bexley.
- " 20-80 To appropriate funds for the clothing allowance previously authorized for supervisory personnel.
- " 21-80 To appropriate funds. (Furniture & Fixtures for Mayor's Office)
- " 22-80 To appropriate funds to reimburse a property owner for sewer repairs caused by excavation for the streetlight project.
- " 23-80 A supplemental appropriation ordinance for 1980 fees for the Disaster Relief Organization.
- " 24-80 To rezone the area bounded by Sheridan Avenue on the west; Mound Street on the south; College Avenue on the east; and the existing Trinity Lutheran Seminary Complex on the north, from R-6 (Medium Density Single Family Residential) to OS (Open Space) and to amend the district boundaries on the Official Zoning Map.
- " 25-80 To appropriate funds and authorize the Mayor to contract with Jennings-Lawrence Company for a sanitary sewer flow measurement study and preparing preliminary design plans for a sanitary relief sewer.

- No. 26-80 To rezone property located on the north side of Main Street, formerly occupied by the Capital University Law School, from Office Commercial (OC) to Community Commercial (CC) and to amend the district boundaries on the Official Zoning Map.
- " 27-80 To rezone property located on the south side of Main Street, between Alum Creek on the west and Sheridan Avenue on the east, from Office Commercial (OC) to Community Commercial (CC) and to amend the district boundaries on the Official Zoning Map.
- " 28-80 To amend the Official Zoning Map by transferring certain property from the Low Density Single Family Residential District to the Planned Unit Residential District; and to give final approval of the development plan for said tract of land.
- " 29-80 Authorizing the negotiation of a contract for purchase of thermoplastic pavement marking materials for Main St.
- " 30-80 Amending Ordinance No. 30-70 by increasing the Water Service Restoration Charge to \$10.00; and to amend Ordinance No. 10-74 by increasing the maximum number of meter readings each year to four.
- " 31-80 To appropriate money from various unencumbered funds and reappropriate it within the various funds for the current operation of several governmental departments.
- " 32-80 To appropriate funds. (Capital Improvements for 1980)
- " 33-80 To make additional appropriations for current expenses and other expenditures for 1980.
- " 34-80 To amend Ordinance No. 15-80 by increasing the total appropriations for the purchase of one Truck Chassis and Cab with Articulating Aerial Tower and Aerial Tower Body.
- " 35-80 To hire special counsel to represent Bexley before the PUCO against Columbia Gas of Ohio, Inc.
- " 36-80 To authorize bids and appropriate funds for the repair and replacement of the heating system in the garage.
- " 37-80 To grant special permit to the Bexley Public Library (stone retaining wall construction).
- " 38-80 To appropriate funds for CASA.
- " 39-80 To appropriate funds. (Salaries for additional services of recreation leaders of the Recreation Dept.)
- " 40-80 To rezone property located on the east side of Cassady Avenue (Marathon Oil Company).
- " 41-80 To appropriate funds. (Flow test studies)
- " 42-80 To purchase and install new 8 inch C.T. water meter.
- " 43-80 To appropriate funds and authorize entering into contract for 701 Planning Grant.
- " 44-80 Authorizing issuance of notes in amount of \$2,200,000 in anticipation of issuance of bonds for streetlight project.
- " 46-80 To increase the salary of the Auditor.
