WHEREAS, a Bexley Neighborhood Stabilization Plan dated August 1981 (the "Plan") has been prepared by the Bexley City Planner with the assistance of the Bexley Planning Commission and a Citizens Advisory Committee, and the Plan has been submitted to this Council;

NOW, THEREFORE, BE IT RESOLVED, BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1: That this Council hereby accepts the Plan in the form presented to it.

Section 2: That this Council hereby adopts the findings set forth at pages 1 through 5, inclusive, of the Plan and the supporting data set forth in the Plan for use in connection with future planning activities within the City of Bexley.

Section 3: That this Council hereby reaffirms that planning and redevelopment activities within the City of Bexley should promote and preserve the existing character of Bexley's neighborhoods.

Section 4: That this Council hereby requests that the Planning Commission and Board of Zoning Appeals develop and submit to this Council appropriate ordinances to implement the principal land use recommendations in the Plan.
