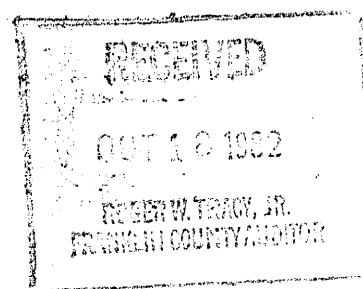
Mr. OFFENBERG moved the adoption of the following Resolution:
