

AMENDED ORDINANCE NO. 49 -82

An Ordinance to authorize the Mayor and Auditor to enter into a publishing agreement with Home Bindery, Inc., for the publication of a Bexley City Guide and to declare an emergency.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That the Mayor and Auditor be, and they hereby are, authorized and directed to enter into a publishing agreement with Home Bindery, Incorporated for the publication of a Bexley City Guide at no cost to the City of Bexley. ~~A copy of said agreement is attached hereto and made part of this Ordinance.~~

Section 2. That this Ordinance is an emergency measure necessary for the immediate preservation of the public peace, health and safety, and this Ordinance shall go into effect upon its passage and approval by the Mayor.

PUBLISHING AGREEMENT

This agreement entered into this _____ day of _____, 1982, by and between Home Bindery, Inc. of Dublin, Ohio herein referred to as the "Publisher" and the City of Bexley who, in consideration of mutual advantages to be gained by the development and publication of a Bexley City Guide, agree to the following:

I. The Publisher agrees to:

- A. Solicit advertising from local business firms explaining how the Bexley Guide will benefit them. The City of Bexley has the right to veto any advertiser whose qualifications do not meet their standards.
- B. Be responsible for all billing and collection of payments for advertising.
- C. Design the Publication's cover (printed in 4-color) and layout style for the inside pages, subject to prior approval by the City of Bexley.
- D. Provide the City of Bexley proofs of editorial copy to be included in the Publication.
- E. Provide the advertisers with proof of their advertisement to be printed in the Publication.
- F. Provide the City of Bexley, without charge, 1,000 copies of the Guide.
- G. Provide up to thirty-two (32) pages, plus cover, for the Publication.
- H. Set up a Production Schedule each year which shall be agreed upon by both parties in advance, allowing adequate time at each stage for proper editorial checks.
- I. Publication shall be delivered on a date mutually agreed upon.
- J. The City of Bexley Guide shall be printed in Dublin by Home Bindery, Inc.
- K. Distribute the Publication to all Bexley, Berwick, and Eastmoor residents.

II. The City of Bexley agrees to:

A. Support the Publication by:

1. Public endorsement of the City Guide with an announcement about the Publication in the Bexley Newspaper.

B. Responsibilities of City of Bexley:

1. Take responsibility for furnishing the necessary editorial copy, photographs to be used, maps and street guides.
2. Read, correct and return proofs of publication by agreed deadlines.

III. Term of Agreement:

This agreement shall be for a term of two (2) years if mutually agreed upon for following year.
