NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, STATE OF OHIO:

Section 1: That the subdivision known as Bexley Heights, was approved and accepted by Ordinance No. 543 passed by the Bexley Village Council on November 11, 1924 and said subdivision was then duly recorded in Plat Book No. 11, pages 15 and 16.

Section 2: That all streets, alleys and rights-of-way indicated on said subdivision were duly dedicated to the public use and duly accepted by the Village of Bexley, now the City of Bexley.

Section 3: That the alley lying between North Drexel Avenue and Northview Drive, running south from Delmar Drive to Caroline Avenue, which is unnamed, is not now used and has never been used by the City as a public alley, and will not be needed for any foreseeable future need and that the Planning Commission of the City, after receiving a petition from a majority of the abutting property owners, unanimously recommended, that the alley be vacated and that such action will not be detrimental to the public interest.

Section 4: That the unnamed unused alley described as follows:

A twenty foot strip, being so-called alley lying to the east of Lots No. 47-54 and to the west of Lots No. 55-64, Bexley Heights Subdivision, and running from Delmar Drive southerly for five hundred and nine feet, more or less, terminating at Caroline Avenue;

Shall and be and the same is hereby vacated and abandoned; provided, however, that the City of Bexley and all persons or companies engaged in the operation of public utilities shall retain, and have, the right to maintain in place, and to construct and erect, all sewers, conduits, pipes, poles, and wires and any other facilities used or useful in the rendition of public utility service and the right of ingress and egress thereover.

Section 5: That this Ordinance shall be and remain in force from and after the earliest period allowed by law.
