An Ordinance to authorize a variance for property located at 2738 East Main Street, to permit the property, which is zoned "office commercial" (OC), to be used for retail sales purposes as a specialty shop for women's apparel.

WHEREAS, Dia Kerr, who does business as Dia's Choice, a women's specialty dress shop, desires to lease property at 2738 East Main Street in Bexley in the Knoll's Realty Building for the purpose of operating a retail store for a fine line of women's apparel; and

WHEREAS, the property is zoned Office Commercial (OC) which does not allow retail or specialty retail stores within the existing zoning; and

WHEREAS, the proposed use satisfies all other requirements of the Zoning Code and is in keeping with many pre-existing non-conforming retail uses within the particular Zoning District.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That, conditioned upon prior approval by the Bexley Planning Commission, and upon the execution of an appropriate lease with the owner of the premises for the exclusive use of 1,200 square feet of the premises, that Dia Kerr, dba Dia's Choice, be granted a special conditional permit to construct and operate a retail sales store for women's apparel, parking areas and accessory facilities thereto on the premises at 2738 East Main Street, Bexley, Ohio.

Section 2. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
