AMENDED ORDINANCE NO. 5-84

An Ordinance to make appropriations for capital improvements during the fiscal year ending December 31, 1984, to authorize capital purchases for said year, and to declare an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That the following sums be and they are hereby set aside and appropriated from the Capitol Improvements Fund:

- (a) \$4,650.00 to be transferred in the following amounts to the departments listed for the purchase of furniture and fixtures during the year 1984; \$1,000.00, Mayor's Office; \$300.00, Police Department; \$2,600.00, City Hall; 2 \$750.00, Water Department:
- (b) \$7,100.00 to be transferred in the following amounts to the Recreation Department for capital improvements during the year 1984; \$1,200.00 for picnic tables; \$2,000.00, Recreation Office Renovations; \$600.00, park grills; \$400.00, park climber; \$2,500.00, Jeffrey Garage roof replacement; and \$400.00, sand volleyball court;
- (c) \$5,500.00 to be transferred in the following amounts to the Parks Department for capital improvements during the year 1984; \$3,200.00 for deciduous and evergreen street trees; and \$2,300.00 for comprehensive street tree inventory and tree management plan;
- (d) \$4,180.00 to be transferred in the following amounts to the Service Department for capital improvements during the year 1984; \$2,980.00 for electrical wiring improvements for City Hall; and \$1,200.00 for a service band base radio station;
- (e) \$31,000.00 to be transferred in the following amounts to the Police Department for the purchase of three vehicles; \$22,000.00 for two police cruisers; and \$9,000.00 for one administrative automobile;
- Section 2. That the Mayor and Auditor be, and they hereby are, authorized and directed to enter into a contract for the purchase of two police cruisers, the total cost of which shall not exceed the sum of \$22,000.00, specified and appropriated above, and the complete specifications for which have been prepared and are on file in the Office of the Mayor;

Section 3. That the Mayor and Auditor be, and they hereby are, authorized and directed to enter into a contract for the purchase of a new 1984 automobile for use by the Police Department, the total cost of which shall not exceed the sum of \$9,000.00, specified and appropriated above, and the complete specifications for which have been prepared and are on file in the Office of the Mayor;

Section 4. Said contracts, when required by law, shall be entered into with the lowest and best bidder after advertisement according to law;

Section 5. That this Ordinance is an emergency ordinance necessary for the immediate preservation of the public peace, health and safety and this Ordinance shall go into effect upon its passage and approval by the Mayor.
