## ORDINANCE NO. 4 -87

An Ordinance to authorize the transfer of funds from the General Fund to the Capital Improvements Fund, to appropriate funds from the Capital Improvements Fund, the Water Fund, the Sewer Fund and Refuse Fund and to declare an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1: That \$321,150 is hereby transferred from the unencumbered General Fund to the Capital Improvements Fund.

Section 2: That \$34,000 is hereby appropriated from the Capital Improvements Fund for the purchase and installation of equipment for the Municipal Garage as follows: heavy duty 3/4 ton pick-up truck - \$13,500, electric welding machine - \$1,500, pneumatic inground truck lift - \$17,000 and ice machine - \$2,000.

Section 3: That \$23,600 is hereby appropriated from the Capital Improvements Fund for the purchase of equipment and materials for the Parks Department as follows: stump cutter -\$10,500, multipurpose sprayer -\$1,700, commercial power mower -\$2,200, development of nursery at North Parkview and Caroline Avenues -\$8,000, and eight (8) honeylocust trees for planting at Main/Drexel -\$1,200.

Section 4: That \$192,500 is hereby appropriated from the Capital Improvements Fund for the 1987 street improvement program described in Exhibit A which is attached hereto and incorporated herein, of which \$96,000 is to be reimbursed from Franklin County Permissive License Tax funds.

Section 5: That \$39,250 is hereby appropriated from the Capital Improvements Fund for the purchase of equipment for the Street Department as follows: spray paint machine - \$7,000, component parts for and installation of 100-120 overhead street lights at various alley locations - \$2,000, two (2) 1/2 ton pick-up trucks - \$22,000, hydraulic pump control system for salt spreader and snow plow equipment on number 19 dump truck - \$5,000, propane tar kettle - \$2,000, and barricades and tools - \$1,250.

Section 6: That \$11,800 is hereby appropriated from the Capital Improvements Fund for the purchase of equipment for the Building Department as follows: Exotox gas meter - \$2,800, and automobile - \$9,000.

Section 7: That \$1,700 is hereby appropriated from the Capital Improvements Fund for the purchase of three (3) hand held mobile radios.

Section 8: That \$18,300 is hereby appropriated from the Capital Improvements Fund for the purchase of equipment and materials for the Recreation Department as follows: installation of additional exterior lighting at Jeffrey Mansion - \$1,300, 1/2 ton pickup truck - \$11,500, and replacement of roof on supervisors' residence on Jeffrey Park grounds - \$5,000.

Section 9: That \$17,200 is hereby appropriated from the Water Fund for the purchase of equipment for the Water Department as follows: 3/4 ton truck and chassis equipped with eight foot utility body - \$15,000, and fifty (50) 1 1/2 inch street valve box heavy duty risers - \$1,200.

Sewer Fund for the purchase of equipment for the Sewer Department

as follows: robotic control for sewer rodding machine - \$3,800, and storm catch basins and sanitary sewer manhole risers - \$1,000.

Section 11: That \$6,600 is hereby appropriated from the Refuse Fund for the purchase of equipment for the Refuse Department as follows: seven (7) commercial refuse boxes - \$5,500, and five (5) pre-cast trash receptacles - \$1,100.

Section 12: That the Mayor and Auditor be, and they hereby are, authorized and directed to enter into contracts for the purchase of the goods and services specified above when and as necessary or desirable.

Section 13: That the contracts authorized herein, when required by law, shall be entered into with the lowest and best bid after advertisement according to law.

Section 14: That this Ordinance is an emergency ordinance necessary for the immediate preservation of the public peace, health and safety in order to commence the 1987 street improvement and other essential services at the earliest possible date and shall go into effect upon its passage and approval by the Mayor.
