An Ordinance to authorize the Mayor and Auditor to execute a contract for concession services at the Bexley Pool and to declare an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That the Mayor and Auditor are hereby authorized to execute a contract for concession services at the Bexley Pool during the period May 23 through September 7, 1987 on such terms and conditions as shall be approved by the Director of Recreation and the City Solicitor; provided, however, that such contract shall not obligate the City to pay the contractor any fee for such services, it being understood that the contractor will retain all proceeds from the concession operation and bear all risk of loss.

Section 2. That this Ordinance is an emergency measure necessary for the immediate preservation of the public peace, health and safety; said emergency being the need to commence concession operations immediately; and, therefore, such Ordinance shall go into effect upon its passage and its approval by the Mayor.
