

ORDINANCE NO. 59-07

SECTION 2: That, upon receipt of a written joint notification by the Mayors of the group of municipalities which have enacted ordinances expressing intent to negotiate a uniform gas rate, the Village/City of Bexley respectfully requests Columbia Gas of Ohio, Inc. to commence negotiations with the uniform gas rate committee to be composed of representatives from the Office of the Consumers' Counsel as well as representatives from the municipalities who choose to attend such negotiations. Unless otherwise indicated, the Office of the Consumers' Counsel will act as principal negotiator and all correspondence, communications, information, etc., shall be provided to the Office of the Consumers' Counsel.

SECTION 3: That, the date the Company receives joint notification by the Mayors shall be the date which designates the commencement of the 90-day period of negotiations for a uniform gas rate.

SECTION 4: That, where such negotiations do not, within ninety days after commencement of negotiations, result in an agreement between the group and the Company, the Group may exercise the rights of a municipal corporation under Section 743.28 of the Ohio Revised Code on the same basis as if it were a single municipal corporation and enact a uniform rate ordinance(s) fixing and regulating the price that may be charged by Columbia Gas of Ohio, Inc., its successors or assigns, for gas to a group of municipal corporations and to their inhabitants, in accordance with Section 743.28 of the Ohio Revised Code amended by Amended House bill No. 156.

SECTION 5: That, should the Company refuse to accept the rates established by a uniform rate ordinance and thereafter file a complaint with the Public Utilities Commission of Ohio, in accordance with Section 4909.34 of the Ohio Revised Code as amended by Amended House Bill No. 156, the Village/City of Bexley requests the Commission to order the Company to file under the Commission's standard filing requirements uniform information for the service area of all municipalities in the group of municipal corporations in order that the Commission may establish a uniform rate which would apply to each municipality in the group.

SECTION 6: That, any ordinance or resolution, or part of an ordinance or resolution, inconsistent herewith, is, to the extent of such inconsistency, hereby repealed.

SECTION 7: That, this ordinance shall become effective and operative within the meaning of Amended House Bill No. 156 on the date delivered to the Company by Consumers' Counsel, the designated counsel herein.

SECTION 8: That, the Office of the Consumers' Counsel is hereby designated as counsel for the Consortium in all matters and in all proceedings arising under this ordinance.

SECTION 9: That, it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open session of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 10: That, this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the citizens of the City of Bexley and shall become effective as stated in Section 7, such being necessary for the continuing safe, legal, proper, economical and efficient operation of the City of Bexley.

ORDINANCE
FOR THE FORMATION OF
A UNIFORM RATE COALITION II

ORDINANCE NO. 59-87

Pursuant to Section 743.28 of the Ohio Revised Code as amended by Amended House Bill No. 156, 113th General Assembly, the Counsel of the Village/City of Bexley hereby notifies Columbia Gas of Ohio, Inc. and the Public Utilities Commission of Ohio of its intent to negotiate jointly with other municipal corporations for the purpose of establishing a uniform gas rate.

BE IT ORDAINED BY THE COUNCIL OF THE Village/City
OF BEXLEY, OHIO:

SECTION 1: That, for purposes of this ordinance, Uniform Rate shall be defined as a single gas rate which would apply to every municipal corporation in the group of municipal corporations passing an ordinance to adopt such a rate.

GROUP OF MUNICIPAL CORPORATIONS, GROUP OF MUNICIPALITIES, GROUP, OR CONSORTIUM shall be defined as those municipal corporations which by ordinance and written notification by the Mayors to the Company have expressed their intent to jointly negotiate a price schedule, until such time as any two or more of such municipalities have jointly presented to the Company ordinances setting or fixing a uniform price schedule for the product of service of the Company; thereafter, Group of Municipal Corporations, Group of Municipalities, Group or Consortium shall mean those municipal corporations which have set uniform price schedules for the product or service of the Company. Those municipal corporations which pass rate ordinances establishing a uniform price schedule and jointly present such rate ordinances to the company are, upon such presentation, to be considered to be a group of municipal corporations, regardless of whether all of the communities which had initially notified the Company of their intent to participate in joint negotiations present such rate ordinances and notwithstanding any prior action by any municipal corporations which do not so present to the company rate ordinance establishing a uniform price schedule. Mayors shall mean mayors of all the municipalities in the group of municipal corporations. Company means Columbia Gas of Ohio, Inc.
