

ORDINANCE NO. 68 - 87

An Ordinance authorizing the Mayor and Auditor to sign an agreement on behalf of the City of Bexley, Ohio, with Northend Community Recycling Center Corporation of 5 West Northwood, Columbus, Ohio, to establish a collection program for recyclable materials in the City of Bexley.

WHEREAS, the Northend Community Center Corporation has proposed to establish the collection of recyclable materials in the City of Bexley, and;

WHEREAS, the collection of recyclable materials by Northend Community Center Corporation benefits the City of Bexley by reducing the quantity of material placed for collection by City Sanitation Personnel, and; therefore, also benefits the City of Bexley by reducing the cost per tonnage for refuse tipping fees, and;

WHEREAS, the program will be operated independent of and without cost to the City of Bexley.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That Northend Community Center Corporation has proposed an agreement with the City of Bexley to establish a collection program for recyclable materials within the City of Bexley.

Section 2. That the Mayor and Auditor be, and they hereby are, authorized to enter into an agreement with Northend Community Center Corporation to establish such a recycling program in the City of Bexley.

Section 3. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.

A G R E E M E N T

The City of Bexley, Ohio ("City") and Northend Community Center Corporation ("Company") agree as follows:

The Company will collect recyclable materials in the parking lot of the Bexley Community Pool, 2100 Clifton Avenue, during the months the pool is closed. During the months that the Bexley Community Pool is open it will be the responsibility of Northend Community Center Corporation to locate an alternative collection point. The Company will collect recyclable materials on the 4th Saturday of each month between the hours of 9:00 a.m. and 3:00 p.m., beginning January 23, 1988. The materials will be received by donation and will include newspaper, cardboard, container glass, aluminum cans, tin-plated steel food cans, aluminum foil, computer and office paper.

The Company will provide suitable containers for the orderly collection of the materials, and will provide the personnel necessary to assist and supervise the collection of the materials. The clean-up and removal of all materials and equipment from the site will be done by the Company on the same Saturday as the collection.

The Company assumes full control over, and supervision of, the agreed upon collection and removal of materials, and holds the City blameless for any act or occurrence resulting therefrom, in which there is injury or damage to any person or property.

The City will not charge any fee to the Company for the use of the parking lot at 2100 Clifton Avenue, or for the donated materials collected.

The Company will attempt to find a second collection site that is more geographically accessible for residents in central and south Bexley. However, nothing herein shall make a second collection site mandatory on the Company.

The City may assist in making its residents aware of the time and place for the collection of recyclable materials.

The term of this agreement shall be one (1) year, commencing November 1, 1987 through October 31, 1988. However, either the City or the Company may cancel this agreement after thirty (30) days written notice.
