

ORDINANCE NO. 43 -88

An Ordinance to authorize the Mayor and Auditor to enter into a contract on behalf of the City of Bexley for the Mosquito Adulticiding and Larviciding Program services for the year 1988, and to declare an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That the Mayor and Auditor are hereby authorized and directed to enter into a contract on behalf of the City for the Mosquito Adulticiding and Larviciding Program services for the year 1988, in the form attached hereto and incorporated herein by reference.

Section 2. That the contract authorized herein, when required by law, shall be entered into with the lowest and best bidder after advertisement according to law.

Section 3. That this Ordinance is an emergency ordinance necessary for the immediate preservation of the public peace, health and safety, said emergency being the necessity to begin the program immediately due to the sudden onset of unseasonably warm weather, and shall go into effect upon its passage and approval by the Mayor.

to pay to Seller, therefore, in monthly payments, full payment for reasonable
charges at the consideration listed above, to be billed by Seller. Buyer may
modify or cancel scheduled service as conditions dictate.
