No. 1-88	To appropriate funds for the period beginning January 1, 1988 and ending on February 28, 1988.
" 2-88	To authorize the Mayor and the Auditor to execute a contract with Clemans, Nelson & Associates, Inc., for management consulting services.
" 3-88	Authorizing the issuance of notes in the amount of \$750,000 in anticipation of the issuance of bonds for the purpose of renovating and improving the Jeffrey Mansion by constructing a 1,050 square foot addition, an additional stairway, firewalls, and public restrooms, adding emergency exits, upgrading electric, heating, air conditioning, and other mechanical systems, repairing plaster walls, and making related improvements and purchasing related equipment and appurtenances therefore.
" 4-88	To authorize the Main Street Banner Program.
" 5-88	<u>SUBSTITUTE</u> - To authorize a contract for architectural services in connection with the restoration and remodeling of Jeffrey Mansion and to appropriate funds.
" 6-88	To appropriate funds. (Franklin Co. Muni. Court)
" 7-88	To certify special assessments for the repair of sidewalks where the work was not done by the owner after being ordered by the City in accordance with Ordinance No. 11-48, and it was necessary for the City to do the work and assess the owner.
" 8-88	To approve the editing and inclusion of certain ordinances as parts of the various component codes of the Codified Ordinances, to provide for the adoption of new matter in the updated and revised Codified Ordinances, to publish the enactment of such new matter, to repeal ordinances in conflict therewith, and to declare an emergency.
" 9-88	To appropriate real property to provide for rehabilitation of the building thereon pursuant to Section 719.012 of the Ohio Revised Code.
" 10-88	To appropriate funds. (Engineering services for Street Project)
" 11-88	To authorize the Mayor and Auditor to enter into a contract with the City Attorney of Columbus and to declare an emergency.
" 12-88	To permit Walter Bakle, formerly the Supervisor of Recreation, to serve as the interim Assistant Director of Recreation, effective as of February 13, 1988, to establish the salary and privileges for such position, and to declare an emergency.
" 13-88	To appropriate funds. (Real Estate Consulting Services)
" 14-88	To amend Sections 1060.10 and 1060.105 of the Codified Ordinances of the City of Bexley to increase the rate for the collection and disposal of garbage, trash, yard trash and brush within the City.
" 15-88	To transfer funds from the unencumbered General Fund to the Capital Improvements Fund, to appropriate funds and authorize contracts for the purchase of services in connection with the supervision and removal of asbestos material from Jeffrey Mansion and to declare an emergency.
" 16-88	Annual Pay Ordinance.
" 17-88	Annual Appropriations Ordinance.

- " 18-88 To appropriate funds. (Hydraulic lift assembly)
- " 19-88 To amend Ordinance No. 89-87 to increase the five member Bexley Charter Review Committee to seven members.
- " 20-88 To appropriate funds. (Recreational uniforms)
- " 21-88 To authorize the Mayor and Auditor to advertise for bids for the purchase of regular leaded, regular unleaded and diesel fuel for the City of Bexley.
- " 22-88 To appropriate funds to pay for the rental, delivery, set-up charges and electrical service for a self contained trailer to be used as temporary office space from April through December, 1988, during the renovation of Jeffrey Mansion, and to declare an emergency.
- " 23-88 To amend Section 2, Part C, of Ordinance No. 16-88
- " 24-88 To authorize the purchase of materials for maintenance and repair of streets for the balance of the year, 1988.
- " 25-88 To authorize a variance to allow for the construction of a decorative stone wall, 48 inches in height, and a wrought iron gate in the front yard setback area at 36 Ashbourne Road (Lot Number 59, Stanbery Place Addition), premises owned by Dr. and Mrs. Gerald M. Rosenberg.
- " 26-88 To appropriate funds. (Capital Improvements Ordinance)
- " 27-88 SUBSTITUTE - To rezone that portion of Lot No. 51 of the Mayfield Place Addition as described.
- " 28-88 INDEFINITELY POSTPONED - to amend the Official Zoning Map adopted as a part of Ordinance No. 8-72 (now Chapters 1240 and 1268, inclusive, of the Codified Ordinances of the City of Bexley), by transferring the following described property. (PUR request for Parkview & Caroline Avenues)
- " 29-88 To transfer and appropriate funds. (1986 Street Improvement Project)
- " 30-88 To amend Section 1490.16 of the Codified Ordinances of the City of Bexley, to provide a penalty for improper house numbers.

- " 33-88 To transfer funds from the unencumbered General Fund to the Teen Center Fund and the Recreation Fund, to transfer funds from the Bond Retirement Fund to the unencumbered General Fund, the Teen Center Fund, the Recreation Fund, and the Capital Improvements Fund.
- " 34-88 To appropriate funds to pay a portion of the cost of repairs to a storm sewer located in an easement at 445 North Parkview Avenue.
- " 35-88 AMENDED - To enact a new Chapter 1440 of the Codified Ordinances of the City of Bexley, Ohio, pertaining to the regulation of exterior area lighting.

- " 36-88 To amend Section 612.02 of the Codified Ordinances of the City of Bexley regarding sale of intoxicating liquor and beer to persons under the age of twenty-one.

- " 52-88 To impose a moratorium on the granting of variances from the minimum lot requirements of the Zoning Code and to declare an emergency.
- " 53-88 To appropriate funds. (Repairs to aerial truck)
- " 54-88 To appropriate funds. (Police Dept. air conditioner)
- " 55-88 To amend the Official Zoning Map adopted as a part of Ordinance No. 8-72 (now Chapters 1240 and 1268, inclusive, of the Codified Ordinances of the City of Bexley), by transferring the following described property.

- " 64-88 To transfer funds from the Bond Retirement Fund to the Capital Improvements Fund, to appropriate funds from the Capital Improvements Fund for the renovation of the Jeffrey Mansion and to declare an emergency.
- " 65-88 To appropriate funds from the unencumbered General Fund, to authorize a contract with National Revenue Corporation for collection services and to declare an emergency.
- " 66-88 To amend Section 1060.09 of the Codified Ordinances of the City of Bexley respecting garbage and trash collection and disposal.
- " 67-88 To authorize the Mayor and Auditor to advertise for bids and to enter into a contract to purchase highway rock salt for the winter of 1988-1989, and to declare an emergency.
- " 68-88 To increase the salary of the Auditor to the City of Bexley, effective as of the term of office commencing January 1, 1990 and thereafter.
- " 69-88 To appropriate funds. (Water & Auditor's Office air conditioning unit replacement)
- " 70-88 To authorize the Mayor and Auditor to advertise for the purchase of trees to plant in Bexley city parks and tree lawns; to appropriate funds, and to declare an emergency.
- " 71-88 * (TABLED TO 1989) To approve, adopt and enact Chapter 1063 and Sections 1063.01, 1063.02 and 1063.99 as Codified Ordinances of the City of Bexley. (Playground safety rules)
- " 72-88 To transfer funds. (Within accounts in Health Dept.)
- " 73-88 To authorize the Mayor and Auditor to execute a contract with the District Health Council of the Franklin County General Health District and to declare an emergency.
- " 74-88 To transfer funds from the unencumbered General Fund to the Capital Improvements Fund and to appropriate funds from the Capital Improvements Fund to pay attorney's fees.

- " 75-88 To transfer funds from the Capital Improvements Fund to the Jeffrey Mansion Construction Account.
- " 76-88 To appropriate funds. (Insurance premiums)
- " 77-88 To appropriate funds. (Ad in Bexley Area Chamber of Commerce Brochure)
- " 78-88 To authorize the Mayor and Auditor to enter into a contract with Lee E. Martin, DBA Benatec Associates, and to declare an emergency.
- " 79-88 To make additional appropriations. (Clean-up Ordinance)
- " 80-88 To amend Section 1470-07 (Real Estate Signs) of the Bexley Codified Ordinances to permit the use of directional open house signs.
