

ORDINANCE NO. 67 -89

An Ordinance authorizing the Mayor and Auditor to sign an amended agreement on behalf of the City of Bexley, Ohio, with Northend Recycling of Columbus of 4254 Morse Road, Columbus, Ohio, to expand a collection program for recyclable materials in the City of Bexley, to appropriate \$500.00, and to declare an emergency.

WHEREAS, Northend Recycling of Columbus established the collection of recyclable materials in the City of Bexley; and,

WHEREAS, the success of the program necessitates expansion of the program to accommodate the volume of materials recycled; and,

WHEREAS, the collection of recyclable materials by Northend Recycling of Columbus benefits the City of Bexley by reducing the quantity of material placed for collection by City Sanitation Personnel and, therefore, also benefits the City of Bexley by reducing the cost per tonnage for refuse tipping fees.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That Northend Recycling of Columbus has proposed an amended agreement with the City of Bexley to expand a collection program for recyclable materials within the City of Bexley.

Section 2. That the Mayor and Auditor be, and they hereby are, authorized to enter into an agreement with Northend Recycling of Columbus to expand the recycling program in the City of Bexley.

Section 3. That the sum of \$500.00 should be, and hereby is, appropriated from the Refuse Fund to Account Number 11-370-119, the Refuse Contract Account.

Section 4. That this Ordinance is an emergency necessary for the immediate preservation of the public peace, health and safety, said emergency being that the current recycling program is unable to handle the volume of material brought to recycling drives, and shall take effect and be in force from and after its passage and approval by the Mayor.

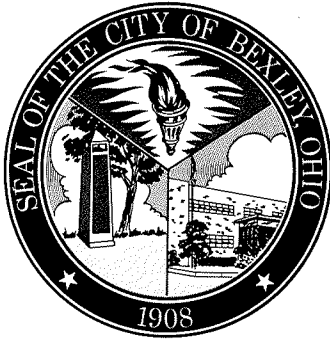

## AGREEMENT

The City of Bexley, Ohio ("City") and Northend Recycling of Columbus ("Company") agree as follows:

The Company will collect recyclable materials in the parking lot of the Bexley Community Pool, 2100 Clifton Avenue, during the months the pool is closed. During the months that the Bexley Community Pool is open it will be the responsibility of Northend Recycling of Columbus to locate an alternative collection point. The Company will collect recyclable materials on the 2nd and 4th Saturdays and on the 4th Tuesday of each month between the hours of 9:00 a.m. and 3:00 p.m., and will include cardboard, container glass, aluminum cans, tin-plated steel food cans, aluminum foil, computer and office paper.

The Company will provide suitable containers for the orderly collection of the materials, and will provide the personnel necessary to assist and supervise the collection of the materials. The clean-up and removal of all materials and equipment from the site will be done by the Company on the same day as the collection.

The Company assumes full control over, and supervision of, the agreed upon collection and removal of materials, and holds the City blameless for any act or occurrence resulting therefrom, in which there is injury or damage to any person or property.

The City will not charge any fee to the Company for the use of the parking lot at 2100 Clifton Avenue, or for the donated materials collected.


The City agrees to pay a monthly charge of \$500.00 to the Company to assist with the cost of operating the drives, and agrees to assist in making it's residents aware of the

time and place for the collection of recyclable materials.

Either the City or the Company may cancel this agreement at any time.


