An Ordinance to appropriate funds from the Capital Improvements Fund, the Sewer Fund, the Refuse Fund, the Street Maintenance and Repair Fund, and the Swimming Pool Fund for capital improvements and to declare an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That the sum of \$51,440.00 is hereby appropriated from the Capital Improvements Fund for the purpose of equipment for the Police Department as follows:

Section 3. That the sum of \$4,966.00 is hereby appropriated from the Capital Improvements Fund for the purchase of equipment for the General Fund activities as follows:

 $\underline{\text{Section 4.}}$  That the sum of \$58,750.00 is hereby appropriated from the Street Maintenance and Repair Fund for the following:

- a) A Dump Truck with a 10'x7' dump body and \$ 36,500.00 central hydraulic system
- b) An asphalt Roller with operating weight \$ 22,250.00 of at least one ton

 $\underline{\text{Section 5.}}$  That the sum of \$17,000.00 is hereby appropriated from the Swimming Pool Fund for a recreation pad for the Swimming Pool.

 $\underline{\text{Section 6.}}$  That the sum of \$12,640 is hereby appropriated from the Refuse Fund for the purchase of the following items:

- a) Heavy Duty Brush Chipper \$ 12,000.00
- b) Two (2) Pre-Cast concrete Trash Receptacles \$ 640.00

 $\underline{\text{Section 7.}}$  That the sum of \$3,200.00 is hereby appropriated from the Sewer Fund for the following:

- a) Purchase of storm catch basin adjusting \$ 1,500.00
- b) Rods, Rod Guide Hose and tools for sewer \$ 1,700.00 rodder machine

Section 8. That the sum of \$300.00 is hereby appropriated from the Water Fund for the purchase of a  $l\frac{1}{2}$ " water pump.

 $\underline{\text{Section 9.}}$  That the sum of \$128,906.00 is hereby appropriated and transferred from the General Fund to the Capital Improvements Fund, and the sum of \$58,750.00 is hereby appropriated and transferred from the General Fund to the Street Maintenance and Repair Fund.

Section 10. That the Mayor and Auditor be, and they hereby authorized and directed to enter into contracts for the purchase of goods and services specified above when and as necessary or desirable.

Section 11. That the contracts authorized herein, when required by law, shall be entered into with the lowest and best bid after advertisement by law.

Section 12. That this Ordinance is an emergency ordinance necessary for the immediate preservation of the public peace, health and safety in order to commence improvements at the earliest possible date and shall go into effect upon its passage and approval by the Mayor.
