- " 67-90 AMENDED - To amend Chapter 1480 of the Codified Ordinances to increase cash clean up bond requirements for demolition, and to require restoration of lots after demolition of a structure.
- " 68-90 To amend Section 1430.02(4)(d) of the Codified Ordinances to include restoration of a site in the cash clean up bond requirements for demolition.
- " 69-90 To amend Chapter 12, Section 1264.12, of the Bexley City Code, to increase the number of Board of Zoning Appeals alternate members.
- " 70-90 To appropriate \$7,110.17 from the General Fund to pay legal fees in connection with the prosecution of litigation in which the City was a party.

- " 75-90 To appropriate \$17,000.00 from General Fund to pay the City's share of the costs of a waterway safety enhancement project for dams and sanitary sewer crossings on Alum Creek.
- " 76-90 SUBSTITUTE - To make additional appropriations for expenses and other expenditures.
- " 77-90 To approve a contract with the City of Columbus, Division of Police, for the services of the Columbus Police Crime Lab.
- " 78-90 To amend Section 1262.02 of the Codified Ordinances to regulate fences and walls or any combination located in the front yard.
- " 79-90 To transfer \$109,625.64 from the Capital Improvements Fund to the General Fund and to appropriate \$7,048.16 from the Capital Improvements Fund to pay expenses incurred with acquisition of property at 2248-50 East Main Street.
- " 80-90 To appropriate \$32,500 from the Capital Improvements Fund for the purchase of a dump truck, to cancel \$36,500 for such purpose from the Street Construction, Maintenance and Repair Fund, to transfer \$17,717 from the Capital Improvements Fund to the Street Construction, Maintenance and Repair Fund to reimburse it for the purchase of an asphalt roller.
