

RESOLUTION NO. 12 -91BY: John H. Offenberg

A Resolution in support of the rates proposed by the Franklin County Solid Waste Management Authority for the disposal of solid waste at the Authority's Sanitary Landfill during the year of 1992.

WHEREAS, the Executive Director of the Franklin County Solid Waste Management Authority has prepared Financial Statements showing the need to increase 1992 fees at the Authority's Sanitary Landfill as shown on the NOTICE OF PUBLIC HEARING dated October 30, 1991 which is attached to and made a part of this Resolution; and,

WHEREAS, after review of the financial statements, the Council of the City of Bexley, Ohio has determined that these rates are adequate and necessary to operate the Authority during 1992. NOW, THEREFORE,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That the Council of the City of Bexley, Ohio supports the rate increase as shown on the NOTICE OF PUBLIC HEARING dated October 30, 1991.

Section 2. That Dorothy Pritchard, Assistant Service Director and member of the Solid Waste Rate Advisory Board of the Franklin County Solid Waste Management Authority, should be, and hereby is, authorized to execute the Motion of the Solid Waste Rate Advisory Board dated October 30, 1991, which is attached to and made a part of this Resolution in accordance with the vote of the Council of the City of Bexley, Ohio.

Section 3. That this Resolution shall take effect immediately upon adoption.

## MEMORANDUM

Re: 1992 Tipping Fee Adjustment

### 1992 Rate Proposal

We held the first meeting of the Advisory Board on October 23 and proposed that the tipping fee be increased from the current level of \$7.50 per cubic yard to \$9.95 effective January 1, 1992. This is the rate approved by both the Advisory Board and the Authority's Board of Trustees in March of this year to take effect July 1, 1991 anticipating transfer of the City's trash plant to the Authority on July 1. The rate increase was rescinded by the Board of Trustees in June when it became clear that transfer of the plant would be delayed beyond July 1.

We are now proposing to the City that the trash plant be transferred on July 1, 1992. In order to accommodate the transfer, we are recommending the rate be increased to \$9.95 on January 1, 1992. By establishing a single rate for the entire year, as opposed to delaying the increase until July 1, the increase in the rate is more modest than it otherwise would be. For example, if the tipping fee remains at \$7.50 until July 1, it would need to be increased to approximately \$12.50 per cubic yard for the remainder of the year.

During the meeting it was suggested that the difference in fees between \$9.95 and \$7.50 collected in the first half of the year be held in escrow until it is needed in the second half of the year after the SWRF is transferred. The Authority committed to doing this and will keep the additional fees collected in a separate fund until needed for the SWRF.
