- NO. 1-92 To authorize the Mayor and Auditor to execute an agreement with Sarah Hubbard Larrimer for recycling consulting services.
- " 2-92 To appropriate \$4,900.00 from the unencumbered Water Fund to pay for termination of water lines to the Nelson Road Water Meter Pit.
- " 3-92 INDEFINITELY POSTPONED - To transfer \$55,000 from the unencumbered General Fund to the Capital Improvements Fund, to appropriate \$55,000 from the Capital Improvements Fund for the purchase of computer equipment in connection with the computerization of various City functions.
- " 4-92 INDEFINITELY POSTPONED - To transfer \$55,000 from the unencumbered General Fund to the Capital Improvements Fund, to appropriate \$55,000 from the Capital Improvements Fund for the purchase of computer software and related services in connection with the modification of such software to City specifications for the computerization of various City functions.
- " 5-92 To increase the sewer rate.
- " 6-92 To transfer \$59,000 from the water fund to the Sewer Fund.
- " 7-92 To rezone and to amend the official zoning map accordingly: Property know as Maryland Avenue School.
- " 8-92 To establish an Enforcement and Education Fund to accept fines imposed by Section 4511.99 (A) of the Ohio Revised Code.
- " 9-92 To authorize the Mayor and Auditor to execute a contract with the Franklin County Public Defender Commission for the defense of indigent defendants before the Municipal Court of Franklin County, Ohio.
- " 10-92 To authorize the Mayor and Auditor to execute a contract with the City Attorney of Columbus, Ohio for legal representation in the Franklin County, Ohio Municipal Court.
- " 11-92 To amend Ordinance No. 66-83 to permit the expansion of the Bexley Marathon Service Station, a nonconforming use located at 396 N. Cassady Avenue.
- " 12-92 AMENDED - Authorizing the issuance of \$400,000 of Bonds for the purpose of renovating and improving the Jeffrey Mansion by constructing a 1,050 square foot addition, an additional stairway, firewalls and public rest rooms, adding emergency exits, upgrading electric, heating, air conditioning and other mechanical systems, repairing plaster walls and making related improvements, and purchasing related equipment and appurtenances therefor, retiring notes previously issued for such purpose.
- " 13-92 To amend Section(s) 1060.01, 1060.05, 1060.06, 1060.07, 1060.09(a), 1060.09(c), and 1060.10(a) of the Codified Ordinances of the City of Bexley regarding the preparation and collection of yard waste.
- " 14-92 To establish rates of pay for all salaried employees, hourly employees, City Attorney, Parking Control Officer, Animal Control Officer, Police Chief, Police Lieutenant, and Police Sergeants of the City of Bexley.
- " 15-92 To grant a variance pursuant to Section 1264.14(c)(2) of the Codified Ordinances for property located at 2010 East Broad Street (St. Charles Preparatory

School) to permit the property which is zoned Open Space (OS) to be used for public parking during the Ameriflora celebration.

- " 16-92 Annual Appropriation Ordinance.
- " 17-92 To authorize the purchase of materials for maintenance and repair of streets for the balance of the year 1992.
- " 18-92 To grant a variance pursuant to Section 1264.14(c)(2) of the Codified Ordinances for property located at 2100 Clifton Avenue (City of Bexley Pool Parking Lot) to permit the property which is zoned Open Space (OS) to be used for public parking during the Ameriflora celebration.
- " 19-92 To transfer \$56,500 from the unencumbered General Fund to the Capital Improvements Fund, to transfer \$56,500 from the Capital Improvements Fund to the Bond Retirement Account for the purpose of paying principal and interest which will be due on certain notes of the City during 1992, and to authorize the reimbursement of the unencumbered General Fund from income tax receipts to be allocated to the Capital Improvements Fund during 1992.
- ² 20-92 To request the cooperation of the Director of the Ohio Department of Transportation in the resurfacing and the replacement of curbs on Drexel Avenue (US Route 40) from Broad Street to Main Street.
- " 21-92 To grant a variance from the minimum lot requirements in accordance with the provisions of Substitute Ordinance No. 51-88 of the City of Bexley for Part of Lot Number 3 of the Livingston Heirs Subdivision, of record in Plat Book 2, Page 278, Recorder's Office, Franklin County, Ohio, to approve the lots as reconfigured pursuant to such variance.
- " 22-92 To certify special assessments for the repair of sidewalks where the work was not done by the owner after being ordered by the City in accordance with Ordinance No. 11-48, and it was necessary for the City to do the work and assess the owner.
- " 23-92 To appropriate \$20,000 from the unencumbered General Fund for the purpose of paying fees and expenses of the City's Employee Relations consultant.
- " 24-92 To authorize the Mayor and Auditor to sign a Consent and Hold Harmless Agreement on behalf of the City of Bexley with the property owners at 936 Montrose Avenue (Lot Numbers 262 and 263; Riders Addition) regarding improvements to be made upon and within the City owned right-of-way of the unimproved portion of Charles Street.
- " 25-92 To appropriate \$1,000 from the unencumbered General Fund for the purpose of paying court reporter fees and to appropriate \$2,743 from the Capital Improvements Fund to pay the fees and expenses of bond counsel.
- " 26-92 To authorize the Mayor and Auditor to enter into a contract for the purchase of term life insurance for City employees.
- " 27-92 To authorize the Mayor and Auditor to enter into a contract with Noble's, Inc. to assist the Bexley Police Department in the enforcement of traffic and safety laws by providing tow-truck and storage services for impounded vehicles.
- " 28-92 To grant a variance from the minimum lot requirements in accordance with the provisions of Substitute Ordinance No. 51-88 of the City of Bexley for Lots Number 21 and 22 of the Bexley Drive Subdivision #2, of record in Plat Book 14, Page 1, Recorder's Office, Franklin County, Ohio,

and to approve the lots as reconfigured pursuant to such variance, and in accordance with Exhibit B.

- " 29-92 To approve a memorandum of understanding granting a 5% wage increase to full-time police radio dispatchers effective January 1, 1992, to authorize the Mayor and Chief of Police to sign the memorandum.
- " 30-92 To adopt and execute the Mid-Ohio Regional Planning Commission's revised financial provisions of the Articles of Agreement.
- " 31-92 To add Section 606.27 to the Bexley General Offenses Code to empower the Bexley Mayor's Court to cite violators for contempt of court and to establish sentencing guidelines for such offenses.
- " 32-92 Proposing to submit an amendment to Section 880.02 of the Codified Ordinances of the City of Bexley increasing the City income tax from the rate of 2% per year to 2¼% commencing January 1, 1993, to the electors at the general election to be held on November 3, 1992.
- " 33-92 To amend Section 880.14 of the Codified Ordinances of the City of Bexley to limit the credit for municipal income taxes or excise taxes levied by municipalities, other than the City of Bexley, to a tax rate of 2% per year commencing January 1, 1993.
- " 34-92 To authorize the City of Bexley, Ohio, Board of Health to execute a contract with the City of Columbus, Ohio, Board of Health, to provide Adult Mosquito Trapping Program services.
- " 35-92 To authorize the Mayor and Auditor to enter into a contract on behalf of the City of Bexley for the Mosquito Adulticiding and Larviciding Program services for the year 1992.
- " 36-92 To authorize the Mayor and Auditor to enter into a lease of the residence located on the Jeffrey Mansion grounds to Dale Killian, an employee of the City, to appropriate \$2,050 from the unencumbered General Fund for the purpose of making improvements to the residence.
- " 37-92 To amend Ordinance No. 14-92 by changing the highest salary rate of the Service Director to \$49,000.
- " 38-92 To appropriate \$28,200 from the unencumbered General Fund.
- " 39-92 To appropriate \$6,819.18 from the Sewer Fund and \$1,641.50 from the Water Fund for payment of inspection services performed by the City's engineers, related to sewer and water line installation at the Walter Jeffrey Subdivision.
- " 40-92 Certifying summary of amounts required from general property tax approved by Budget Commission, and County Auditor's estimated rates.
- " 41-92 Authorizing the Mayor and Auditor to sign a Consent and Hold Harmless Agreement on behalf of the City of Bexley with the property owners at 2364 Caroline Avenue.
- " 42-92 To authorize the Mayor and Auditor to execute an agreement with Paul Solomon for sanitarian services.
- " 43-92 SUBSTITUTE ORDINANCE - To amend the Codified Ordinances of the City of Bexley by deleting Chapter 1470 and re-enacting Chapter 1470, with certain amendments, as Chapter 1230 of the Bexley Planning and Zoning Code, to regulate signs with regard to location, type, number, size and design.

- " 44-92 SUBSTITUTE ORDINANCE - To amend the Codified Ordinances of the City of Bexley by deleting Chapter 1432 and re-enacting Chapter 1432, with certain amendments, as Chapter 1222 of the Bexley Planning and Zoning code, to establish controls and regulations regarding the character, design, placement and relationship of buildings, structures and spaces within the Bexley Environmental Review District.
- " 45-92 To appropriate \$2,000 from the Capital Improvements Fund for the purchase of computer hardware and software for use by the Bexley Police Department.
- " 46-92 To authorize the Mayor and Auditor to enter into a contract for the purchase of four police cruisers, and accessories, at a price of not more than \$70,000 for delivery and payment on or after January 1, 1993.
- " 47-92 To transfer \$25,000 from the Swimming Pool Fund to the Capital Improvements Fund, to appropriate \$25,000 from the Capital Improvements Fund for the purpose of remodeling the outdoor rest room facility in Jeffrey Park, to authorize the Mayor and Auditor to enter into contracts for such project, to authorize the reimbursement of the Swimming Pool Fund from the unencumbered General Fund when funds become available for such purpose.
- " 48-92 To grant a variance pursuant to Section 1264.14(C)(2) of the Codified Ordinances for property located at the rear of 2681 East Main Street to permit the property which is zoned Office Commercial (OC) to be used for retail service purposes.
- " 49-92 To appropriate \$1,579.75 from the unencumbered General Fund for the purpose of paying the City's deductible to National Casualty Company in connection with the defense and settlement of a claim by it.
- " 50-92 To amend Chapter 452 of the Codified Ordinances by adding Section 452.21 prohibiting the use of skateboards and similar devices in parking lots and similar areas.
- " 51-92 Approving a change to a Detailed Development Plan for a Planned Unit Residential (PUR) Development known as Bexley Village, previously approved by Ordinance No. 38-69.
- " 52-92 To authorize a variance to allow two limestone entry monuments to be constructed in the front yard setback area at property known as the Walter Jeffrey Addition, 299 through 309 North Parkview Avenue (formerly 303 North Parkview Avenue), premises owned by Malcolm D. Jeffrey, Nancy Jeffrey Kingsley, and Walter Jeffrey, Jr.
- " 53-92 To authorize the Mayor and Auditor to execute an agreement with Denham L. Pride.
- " 54-92 To authorize a variance to allow a 48 inch high wood fence to be constructed in the front yard setback area at 267 North Parkview Avenue (Lot Nos. 7 & 8; Bullitt Park Addition), premises owned by Franklin E. and Linda S. Kass.
- " 55-92 To appropriate funds in the amount of \$85,000.00 from the Sewer Fund for the purchase of a sewer flusher and easement machine.
- " 56-92 To appropriate \$9,000.00 from the Sewer Fund to pay for smoke testing of certain sanitary sewers in the City of Bexley.
- " 57-92 AMENDED - To transfer \$33,600 from the unencumbered General

Fund to the Capital Improvements Fund, to appropriate \$33,600 from the Capital Improvements Fund for the purpose of purchasing play equipment for Jeffrey Park.

- " 58-92 To appropriate supplemental contract professional funds in the amount of \$20,000.00 to pay Building Department inspectors for the remainder of 1992.
- " 59-92 Authorizing the appropriation of \$28,000 from the unencumbered General Fund.
- " 60-92 Authorizing the Mayor and Auditor to execute a contract with The Walter H. Drane Company for services in connection with the annual updating of the Codified Ordinances of the City.
- " 61-92 SUBSTITUTE - Authorizing the Mayor and Auditor to sign a Consent and Hold Harmless Agreement on behalf of the City of Bexley with the property owner at 2556 Sherwood Road (Lot Number 301; Bexley Park Addition) regarding improvements to be made upon and within the City owned right-of-way of Sherwood Road.
- " 62-92 To appropriate \$20,500 from the unencumbered General Fund for the purpose of paying various City operating expenses.
- " 63-92 To increase the water rate charged by the City of Bexley.
- " 64-92 To increase the sewer rate charged by the City of Bexley.
- " 65-92 To appropriate the amount of \$1,500.00 from the Water Fund for the purpose of testing for lead and copper in drinking water as mandated by the United States Environmental Protection Agency.
- " 66-92 To authorize the Mayor and Auditor to execute an agreement with Evans, Mechwart, Hambleton & Tilton, Inc. for professional engineering services.
- " 67-92 To authorize the Mayor and Auditor to enter into a contract with the Director of Public Safety, City of Columbus, to provide fire protection and emergency medical services to the City of Bexley.
- " 68-92 To authorize the Mayor and Auditor to enter into a lease-purchase agreement for equipment to upgrade the City's 9-1-1 system, to appropriate \$427.79 from the unencumbered General Fund for the first month's lease payment.
- " 69-92 To amend Ordinance No. 14-92 to authorize the position of Grounds Maintenance Supervisor (Jeffrey Mansion), to authorize a second position of Secretary to the Recreation Department.
- " 70-92 TABLED - To amend Ordinance No. 14-92 to authorize the position of Finance Director/ Deputy Auditor.
- " 71-92 To amend Section 1430.02(a)(2) of the Codified Ordinances of the City of Bexley to increase plumbing permit fees charged by the Bexley Building Department.
- " 72-92 To amend Section 262.02 of the Codified Ordinances of the City of Bexley regarding certain benefits of the Police Sergeants effective as of January 1, 1992.
- " 73-92 To appropriate funds for the period beginning January 1, 1993 and ending March 31, 1993.
- " 74-92 To make additional appropriations for Fiscal Year end 1992 for current expenses and other expenditures of the City of Bexley.
- " 75-92 To establish rates of pay for all full-time salaried and

hourly employees listed in Schedules I, II and III of Ordinance No. 14-92, as amended, to establish the co-payment requirement for all participants under the City's health insurance program for 1993, to adopt a Flexible Spending Account Plan.
