

ORDINANCE NO. 42 -92

An Ordinance to authorize the Mayor and Auditor to execute an agreement with Paul Solomon for sanitarian services and to declare an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That the agreement with Paul Solomon is hereby approved in the form attached to this Ordinance and that the Mayor and Auditor are hereby authorized and directed to execute said agreement on behalf of the City.

Section 2. That this Ordinance is an emergency measure necessary for the immediate preservation of the public peace, health and safety, said emergency being the need to provide uninterrupted sanitarian services, which shall take effect and be in force upon its passage and approval by the Mayor.


C O N T R A C T

BETWEEN THE CITY OF BEXLEY, OHIO, AND PAUL SOLOMON,
HEREINAFTER REFERRED TO AS SOLOMON.


WITNESSETH

- Section 1. Solomon, shall, for the consideration hereinafter stated, furnish to the City of Bexley, Ohio sanitarian services specified in Ohio Revised Code Section 3709.15, the scope of such services to be determined, from time to time, by the City Health Commissioner.
- Section 2. Solomon shall participate in the Public Employees Retirement System but shall not participate in the City's insurance programs, except workers compensation.
- Section 3. This contract shall remain in force for an indefinite period; provided, however, that either party shall have the right to cancel the contract upon thirty (30) days written notice to the other party.
- Section 4. The City of Bexley, Ohio, shall pay to Solomon for said services the annual rate for sanitarian established, from time to time, by ordinance (currently \$9.72 per hour), which annually shall not exceed the amount appropriated for this purpose.
- Section 5. Said sum or sums of money shall be paid by the City to Solomon upon submission of a statement setting forth the number of hours worked by him during the payment period.

IN WITNESS WHEREOF, the parties to this agreement have hereunto set their hands and seals and have executed this agreement this 8th day of September, 1992.




