- " 6-93 To transfer \$1,500.00 from the unencumbered General Fund to the Capital Improvements Fund, to appropriate \$1,500.00 from the Capital Improvements Fund for the purpose of paying additional costs for the remodeling of the outdoor restroom facility in Jeffrey Park.
- " 7-93 To transfer \$50,000 from the unencumbered General Fund to the Capital Improvements Fund and to appropriate \$70,000 from the Capital Improvements Fund for the purchase of four police cruisers with accessories.
- " 8-93 Annual Appropriation Ordinance.
- " 9-93 To authorize the Mayor and Auditor to execute an agreement with Sarah Hubbard Larrimer for recycling consulting services.
- " 10-93 Authorizing the issuance of notes in the amount of \$350,000 in anticipation of the issuance of bonds for the purpose of making improvements to the water distribution system in the City of Bexley.
- " 11-93 To appropriate \$10,000.00 from the unencumbered General Fund to Account Number 21-330-137.1 S.B.A. Tree Program, for the purpose of paying the City of Bexley's share of a tree planting grant.
- " 12-93 To authorize the Mayor and Auditor to enter into a contract with Stanley E. Duke for the purpose of providing back-up electrical inspection services.
- " 13-93 To appropriate \$3,164 from the unencumbered General Fund to pay the City's share of operating costs of the Municipal Court of Franklin County, Ohio, pursuant to Section 1901.26 of the Ohio Revised Code.
- " 14-93 To authorize the Mayor and the Auditor to execute an agreement with Sticklen-Belsheim & Associates for general traffic engineering services related to traffic regulations, control and design.
- " 15-93 To appropriate the sum of \$30,000.00 from the unencumbered General Fund for professional engineering services related to the planning and programming of the Broad and Main Street Signalization and Street Lighting projects, to authorize the contracting for said projects with SticklenBelsheim & Associates.
- " 16-93 To authorize the purchase of materials for maintenance and repair of streets for the balance of the year 1993.

- " 17-93 To certify special assessments for the repair of sidewalks where the work was not done by the owner after being ordered by the City in accordance with Ordinance No. 11-48, and it was necessary for the City to do the work and assess the owner.
- " 18-93 To appropriate \$40,000 from the unencumbered Capital Improvements Fund to pay the costs of purchasing a replacement truck for the aerial lift truck which was destroyed by fire, to authorize the Mayor and Auditor to enter into a contract for the truck.
- " 19-93 To appropriate \$12,000 from the unencumbered General Fund to pay for the services of a fire inspector, to authorize the Mayor and Auditor to execute an agreement with William Payne for fire investigation and inspection services.

- " 20-93 To transfer \$364,482 from the unencumbered General Fund to the Capital Improvements Fund; to appropriate \$364,482 from the Capital Improvements Fund, \$1,500 from the Refuse Fund, \$1,100 from the Sewer Fund and \$5,000 from the Swimming Pool Fund, all for the purpose of making capital improvements as specified in the Ordinance.
- " 21-93 To approve a contract by and among the City of Bexley, the Board of County Commissioners of Franklin County and the Sheriff of Franklin County for the housing of prisoners effective July 1, 1993, to authorize the Mayor and Auditor to execute said contract on behalf of the City.
- " 22-93 To rescind Ordinance No. 19-93, to amend Schedule V of Ordinance No. 14-92 to create a part-time position of Fire Inspector, to appropriate \$12,000 from the unencumbered General Fund to pay the wages of the Fire Inspector during 1993.
- " 23-93 To grant a variance pursuant to Section 1264.14(c)(2) of the Codified Ordinances for property located at 2651 East Main Street to permit the property, which is zoned Office Commercial (OC), to be used for retail sales purposes.
- " 24-93 Authorizing the Mayor and Auditor to sign a Consent and Hold Harmless Agreement on behalf of the City of Bexley with the property owner at 2462 Powell Avenue. *24" stone wall*
- " 25-93 To transfer \$436,829 from the unencumbered General Fund to the Capital Improvements Fund; to appropriate \$436,829 from the Capital Improvements Fund and \$80,000 from the Refuse Fund for the purpose of making capital improvements as specified in the Ordinance
- " 26-93 To authorize the Mayor and Auditor to enter into a contract on behalf of the City of Bexley for the Mosquito Adulticiding and Larviciding Program services for the year 1993.
- " 27-93 To authorize the City of Bexley, Ohio, Board of Health to execute a contract with the City of Columbus, Ohio, Board of Health, to provide Adult Mosquito Trapping Program services.
- " 28-93 To amend Sections 1020.01 through 1020.03 of the Codified Ordinances of the City of Bexley to reflect current practice with regard to excavations on City-owned property.
- " 29-93 To authorize the Mayor and Auditor to contract with the Board of County Commissioners, Franklin County, Ohio, on behalf of the City of Bexley for a Community Development Block Grant Program and provide acquisition services therewith.
- " 30-93 Authorizing the issuance of notes in the amount

of \$15,000 in anticipation of the issuance of bonds for the purpose of making improvements to various parks in the City of Bexley, Ohio, including the acquisition of all necessary equipment and related appurtenances therefor.

- " 31-93 Authorizing the issuance of notes in the amount of \$105,000 in anticipation of the issuance of bonds for the purpose of making improvements to various buildings in the City of Bexley, Ohio, including the acquisition of all necessary equipment and related appurtenances therefor.
- " 32-93 Authorizing the issuance of notes in the amount of \$245,000 in anticipation of the issuance of bonds for the purpose of purchasing equipment for various City Departments in the City of Bexley, Ohio, including the acquisition of all related appurtenances therefor.
- " 33-93 Authorizing the issuance of notes in the amount of \$270,000 in anticipation of the issuance of bonds for the purpose of purchasing vehicles for use by various City departments in the City of Bexley, Ohio, including the acquisition of all necessary equipment and related appurtenances therefor.
- " 34-93 Authorizing the issuance of notes in the amount of \$365,000 in anticipation of the issuance of bonds for the purpose of making improvements to various streets in the City of Bexley, Ohio, including the acquisition of all necessary equipment and related appurtenances therefor.
- " 35-93 INDEFINITELY POSTPONED - To authorize the Mayor and Auditor to enter into a contract on behalf of the City of Bexley and the Franklin County Emergency Management Agency for the purchase and installation of a new siren.
- " 36-93 To establish an encumbered fund for the Friends of Jeffrey Park to receive private contributions for projects at Jeffrey Park, to appropriate moneys from such fund as received from time to time by the City.
- " 37-93 To establish rates of pay for certain appointed officials and part-time, temporary and casual employees for the year 1993 by amending Schedules IV and V of Ordinance No. 14-92, as amended.
- " 38-93 Summary of amounts required from general property tax approved by Budget Commission, and County Auditor's estimated rates. *Franklin Co. budget*
- " 39-93 To appropriate \$65,000.00 from the General Fund to the Street Fund for the purpose of repairing sections of brick paving on North Roosevelt Avenue between Broad Street and Maryland Avenue.
- " 40-93 To authorize the Mayor and Auditor to execute an agreement with Denham L. Pride.
- 41-93 To authorize the Mayor and Auditor to enter into a contract with James G. Mitchell for the purpose of providing backup Chief Building Official services.
- " 42-93 To appropriate funds in the amount of \$750.00 from the General Fund to Account #01-350-132.1 to pay fees assessed by the State of Ohio Board of Building Standards.
- " 43-93 To transfer \$33,939.92 from the unencumbered Street Maintenance/Special Projects Fund to Account #19-388132 for the purpose of refunding unspent monies received from the Franklin County \$5.00 Permissive Tax Fund.
- " 44-93 To amend Section 648.11 of the Codified Ordinances

to prohibit the parking and operation of commercial vehicles under specified conditions within 175 feet of a residential property.

- " 45-93 SUBSTITUTE ORDINANCE To amend Section 618.07 of the Codified Ordinances to prohibit the keeping within the City of animals which make excessive noise.
- " 46-93 To appropriate \$4,500.00 from the unencumbered General Fund, to transfer \$2,000.00 from the Swimming Pool Fund, and to appropriate said amount for the purpose of paying operating expenses and utility bills at the Jeffrey Mansion.
- " 47-93 SUBSTITUTE ORDINANCE - To transfer \$60,000.00 from the unencumbered General Fund to the Sewer Fund and to appropriate \$60,000.00 from the Sewer Fund to pay for City-wide smoke testing of sanitary sewers in the City of Bexley.
- " 48-93 INDEFINITELY POSTPONED - To transfer \$3,000.00 from the unencumbered General Fund to the Recreation Fund, to appropriate said amount from the Recreation Fund to Account #05-520-132.1 (Recreation Department Special Events), and to authorize the Mayor and Auditor to execute an agreement with Aaron Leventhal for the purpose of planning a Book Fair.
- " 49-93 INDEFINITELY POSTPONED - To transfer \$10,000.00 from the General Fund to the Capital Improvements Fund; to appropriate \$10,000.00 from the Capital Improvements Fund for the purchase of a computerized salt spreader controller; to authorize the Mayor and Auditor to enter into a contract for the purchase of said equipment.
- " 50-93 To appropriate \$1,400.00 from the unencumbered General Fund to Account No. 01-100-118. (*Advtg. in C. of Commerce book*)
- " 51-93 To transfer \$801,311 to the unencumbered General Fund from the Capital Improvements Fund, representing a portion of the proceeds of certain notes issued by the City, for the purpose of reimbursing the unencumbered General Fund for monies transferred to, and appropriated from, the Capital Improvements Fund by Ordinance Nos. 22-93 and 25-93.
- " 52-93 To transfer \$80,000 from the Capital Improvements Fund to the Refuse Fund to pay for the purchase of a twentyfive yard refuse packer truck as authorized by Ordinance No. 25-93.
- " 53-93 To appropriate \$38,929.00 from the Capital Improvements Fund to the Street Renovation/Overlay Account #13-855143 for the purpose of completing the 1993 Street Project.
- " 54-93 Appropriating \$35,000.00 from the Special Assessments Fund for the purpose of paying for the 1993 Sidewalk Replacement Program.
- " 55-93 To appropriate \$30,000 from the unencumbered General Fund to pay salary and benefits of four additional police officers for the remainder of 1993.
- " 56-93 Accepting an easement for a water line from the Bishop of the Catholic Diocese of Columbus over the property occupied by St. Charles Preparatory School.
- " 57-93 PENDING - To amend Sections 434.01(g) and 436.99 of the Codified Ordinances. *Removed from table & defeated 1-11-00.*
- " 58-93 To amend Section 2D of Ordinance No. 25-93 to increase the amount appropriated to \$76,658.00 for the purpose of paying additional costs related to the purchase of Street Department equipment and to declare an emergency.
- " 59-93 To establish a Records Commission for the City of

Bexley pursuant to Section 149.39 of the Ohio Revised Code.

- " 60-93 To transfer \$70,000 from the unencumbered General Fund to the Street Construction and Repair Fund, to transfer \$61,300 from the Capital Improvements Fund to the Bond Retirement Fund to appropriate \$24,586.05 from the unencumbered General Fund, to appropriate \$1,100 from the Street Fund, to appropriate \$2,000 from the Refuse Fund and to appropriate \$3,000 from the Swimming Pool Fund, all for the purpose of paying expenses of the City for the Calendar year 1993.
- " 61-93 To transfer \$45,000 from the General Fund to the Recreation Fund, to appropriate \$1,000 from the General Fund and to appropriate \$9,825 from the Recreation Fund, all for the purpose of paying expenses of the City Recreation and Parks Department.
- " 62-93 To authorize the Mayor and Auditor to execute an agreement with Evans, Mechwart, Hambleton & Tilton, Inc. for professional engineering services.
- " 63-93 An Ordinance consenting, pursuant to Section 406.04 of the Codified Ordinances, to the designation by the Mayor of the alley directly south of East Main Street between Vernon Road and South Remington Road as one-way moving west and between Vernon Road and South Roosevelt Avenue as one-way heading east.
- " 64-93 DEFEATED - To amend Section 1060.10 of the Codified Ordinances of the City of Bexley to increase the rate for the collection and disposal of garbage, yard waste and brush within the City.
- " 65-93 To authorize the Mayor and Auditor to execute an agreement with Sarah Hubbard Larrimer for recycling consulting services.
- " 66-93 To authorize the Mayor and Auditor to enter into contracts with Donald W. Schofield, Class I Chief Building Official and Class II Plans Examiner; James G. Mitchell, backup Class I Building Official and back-up Class II Plans Examiner; Harold S. Schofield, back-up Class II Plans Examiner and back-up Class III Building Inspector; Kurt F. Grashel, Class III Building Inspector; James Barlow, Electrical Inspector; Stanley E. Duke, back-up Electrical Inspector; and, the District Advisory Council of the Franklin County General Health District, primary and back-up Plumbing Inspector, for the purpose of providing building inspection services.
- " 67-93 To amend Section 3 of Ordinance No.25-93 to delete appropriation in the amount of \$80,000. for 25 yd. packer truck, to transfer \$1000. from the unencumbered General Fund to the Recreation Fund, to appropriate \$5000. from the General Fund, to appropriate \$4500. from the Street Construction and Repair Fund, to appropriate \$7488. from the Recreation Fund, to appropriate \$10,000. from the Refuse Fund, to appropriate \$2500. from the Swimming Pool Fund, all for the purpose of paying expenses of the City for the calendar year 1993.
- " 68-93 To appropriate funds for the period beginning January 1, 1994 and ending March 31, 1994.
