An Ordinance accepting an easement of Malcolm D. Jeffrey, Nancy J. Kingsley and Walter Jeffrey, Jr., for sanitary sewer purposes.

WHEREAS, Malcolm D. Jeffrey, Nancy J. Kingsley, and Walter Jeffrey, Jr. have agreed to execute their certain easement to the City of Bexley, Ohio, for the purpose of operating, maintaining and repairing a sanitary sewer line, together with the right of access to said easement for said purposes, over and through the following described real estate to wit:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

That the Mayor and Auditor be, and they hereby are, authorized and directed to accept a Deed of Easement to the City of Bexley, Ohio, for the purpose of operating, maintaining and repairing a sanitary sewer line, and that said Deed of Easement is attached hereto and made a part hereof.

That this Ordinance shall take effect on the Section 2. earliest date permitted by law.

The undersigned MALCOLM D. JEFFREY, married, NANCY J. KINGSLEY, married, and WALTER JEFFREY, JR., married (hereinafter collectively "Grantors"), in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration paid by the CITY OF BEXLEY, OHIO, a municipal corporation (hereinafter "Grantee"), the receipt and sufficiency of which are hereby acknowledged, do hereby grant to Grantee, its successors and assigns, forever, a perpetual, non-exclusive easement in, over, under and through the real property legally described in Exhibit "A" attached hereto and made a part hereof for the purposes of constructing, operating, maintaining, repairing and replacing a sanitary sewer line and appurtenances thereto, together with the right of access to said easement for said purposes.

A sanitary sewer and appurtenant works are to be constructed within the easement area by Grantors at their expense and in accordance with plans and specifications approved by Grantee. By acceptance hereof, Grantee agrees to maintain the sanitary sewer and appurtenant works upon completion by Grantors and inspection and acceptance by Grantee.

Grantee, as soon as is practicable after all entries made pursuant to the rights granted herein, shall restore the surface area to its former condition as nearly as is reasonably possible.

The rights granted herein shall not be construed to interfere with or restrict Grantors' use of the easement area, except that no structure, building, facility, or improvement (other than pavement) shall be constructed within the easement area.

Grantors hereby covenant with Grantee that Grantors are the true and lawful owners of the above described real property and are lawfully seized of the same in fee simple and have good right and full power to grant this easement.

To have and to hold said easement unto Grantee, its successors and assigns forever, for the uses and purposes set forth herein.


