

ORDINANCE NO. 9 -93

An Ordinance to authorize the Mayor and Auditor to execute an agreement with Sarah Hubbard Larrimer for recycling consulting services.

WHEREAS, Sarah Hubbard Larrimer has been providing such services to the City; and,

WHEREAS, it is in the best interest of the City to contract for such services. NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That the agreement with Sarah Hubbard Larrimer is hereby approved in the form attached to this Ordinance and that the Mayor and Auditor are hereby authorized and directed to execute said agreement on behalf of the City.

Section 2. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.


C O N T R A C T

BETWEEN THE CITY OF BEXLEY, OHIO, AND SARAH HUBBARD LARRIMER,
RECYCLING CONSULTANT, HEREINAFTER REFERRED TO AS SARAH H.
LARRIMER.


WITNESSETH

- Section 1. Sarah H. Larrimer, Recycling Consultant, shall, for the consideration hereinafter stated, furnish to the City of Bexley, Ohio, and the inhabitants thereof, recycling consulting services as an independent contractor and not as an employee, to include: monitor existing recycling program, including collection methods, equipment and disposal of recyclables; design programs for the continuing education of Bexley inhabitants about recycling; and, assist the City in the continuing implementation and evaluation of media and recycling programs.
- Section 2. Said services shall be furnished for a period beginning March 15, 1993, and remaining in force until December 31, 1993, provided, however, that either party to this agreement shall have the right to cancel the same upon thirty (30) days written notice.
- Section 3. The City of Bexley, Ohio, shall pay to Sarah H. Larrimer for said Recycling Consultant services furnished to the City of Bexley, Ohio, and the inhabitants thereof, \$11.00 per hour, not to exceed the amount appropriated for this purpose.
- Section 4. Said sum or sums of money shall be paid by the City of Bexley, Ohio, to Sarah H. Larrimer upon submission of a statement setting forth the number of hours worked by her during the payment period.

IN WITNESS WHEREOF, the parties to this agreement have hereunto set their hands and seals and have executed this agreement this 9th day of March, 1993.


