CONTRACT

BETWEEN THE CITY OF BEXLEY, OHIO, AND SARAH HUBBARD LARRIMER, RECYCLING CONSULTANT, HEREINAFTER REFERRED TO AS SARAH H. LARRIMER.

WITNESSETH

- Section 1. Sarah H. Larrimer, Recycling Consultant, shall, for the consideration hereinafter stated, furnish to the City of Bexley, Ohio, and the inhabitants thereof, recycling consulting services as an independent contractor and not as an employee, to include: monitor existing recycling program, including collection methods, equipment and disposal of recyclables; design programs for the continuing education of Bexley inhabitants about recycling; and, assist the City in the continuing implementation and evaluation of media and recycling programs.
- Section 2. Said services shall be furnished for a period beginning January 1, 1994, and remaining in force until December 31, 1994, provided, however, that either party to this agreement shall have the right to cancel the same upon thirty (30) days written notice.
- Section 3. The City of Bexley, Ohio, shall pay to Sarah H. Larrimer for said Recycling Consultant services furnished to the City of Bexley, Ohio, and the inhabitants thereof, \$11.55 per hour, not to exceed the amount appropriated for this purpose.
- Section 4. Said sum or sums of money shall be paid by the City of Bexley, Ohio, to Sarah H. Larrimer upon submission of a statement setting forth the number of hours worked by her during the payment period.
