ORDINANCE NO. 27 -94

An Ordinance to transfer \$186,106 from the unencumbered General Fund to the Capital Improvements Fund, to appropriate \$186,106 from the Capital Improvements Fund for various capital improvements set forth in the ordinance, to authorize the reimbursement of the unencumbered General Fund for such expenditures from funds deposited in the Capital Improvements Fund and to declare an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That \$186,106 is hereby transferred from the unencumbered General Fund to the Capital Improvements Fund.

Section 2. That \$186,106 is hereby appropriated from the Capital Improvements for the following purposes:

Section 3. That the Mayor and Auditor are hereby authorized and directed to enter into contracts for the improvements authorized by Section 2 hereof and that such contracts, when required by law, shall be entered into with the lowest and best bidder after advertisement according to law.

Section 4. That the Auditor is hereby authorized and directed to reimburse the unencumbered General Fund for said improvements from funds deposited, from time to time, in the Capital Improvements Fund to the extent that funds are available for such purpose.

Section 5. That this Ordinance is an emergency measure necessary for the immediate preservation of the public peace, health and safety, said emergency being the need to complete certain of the capital improvements during the 1994 construction season and to assure the uninterrupted provision of adequate public services, which shall go into effect upon its passage and approval by the Mayor.
