

ORDINANCE NO. 62-94

An Ordinance to authorize the Mayor and Auditor to execute an agreement with the District Advisory Council of the Franklin County General Health District for the provision of certain public health services and to declare an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That the Mayor and Auditor are hereby authorized and directed to execute on behalf of the City a contract with the District Advisory Council of the Franklin County General Health District for the provision of certain public health services within the City in the form attached to this Ordinance and incorporated herein by reference.

Section 2. That this Ordinance is an emergency measure, necessary for the immediate preservation of the public peace, health and safety, said emergency being the necessity of providing uninterrupted public health services within the City, and this Ordinance shall go into force and effect upon its passage and approval by the Mayor.

CONTRACT

BETWEEN THE BOARD OF HEALTH OF THE CITY OF BEXLEY, OHIO, AND THE DISTRICT ADVISORY COUNCIL OF THE FRANKLIN COUNTY GENERAL HEALTH DISTRICT.

WITNESSETH

SECTION 1. The District Advisory Council of the Franklin County General Health District shall for the consideration hereinafter stated, furnish to the City of Bexley, Ohio, and inhabitants thereof, all such supplemental public health services for the purpose of meeting minimum public health standards as are furnished by said Council to all villages and townships and the inhabitants thereof, of Franklin County, Ohio. Said supplemental services as are furnished shall include the following:

- 3701-36-05 Health Education
- 3701-36-06 Communicable Disease Control
- 3701-36-07 Chronic Disease Control
- 3701-36-08 Genetic Disease Control
- 3701-36-09 Primary Care
- 3701-06-10 Laboratory Services
- 3701-06-14 Vector Control
- 3701-06-17 Child Health
- 3701-06-18 Nutrition Services
- 3701-06-20 Family Planning
- 3701-06-21 Substance Abuse
- 3701-06-22 Disaster Preparedness
- 3701-06-23 Accident Prevention

SECTION 2. Robert A. Everhart, M.D. will act as Medical Advisor and Mary Jo Steiner, R.N., M.P.H., Ph.D will act as Director of Nursing.

SECTION 3. Whenever any additional service or any new program is planned, approval of the City Council must be secured unless an actual emergency endangering the public health exists. Any program offered as an optional activity must be approved by the City Council. In cases where court action may be necessary in order to secure the public health, the Mayor of the City shall be informed of the legal action proposed by the representatives of the Health Department and he shall agree thereto.

SECTION 4. Said public health services shall be furnished beginning January 1, 1995 and ending December 31, 1995, provided, however, that either party to this agreement shall have the right to cancel the same upon four months written notice and the parties hereto may, by mutual written agreement, modify the terms of this agreement, and payment shall be prorated to date on cancellation.

SECTION 5. The Health Department shall render a report every thirty (30) days to the Health Commissioner of the City of Bexley on all services directly rendered to the Bexley Citizens. Such a report shall describe the type of service, where and for whom the service was rendered, and the number of cases, visits or other appropriate work units.

SECTION 6. The City of Bexley, Ohio shall pay to the Franklin County General Health District for said supplemental public health services furnished the City of Bexley, Ohio and the inhabitants thereof, such sum in the amount of Five Thousand Dollars (\$5,000.00) to be billed annually on the first day of January.

SECTION 7. Said sum of money shall be paid by the said City of Bexley, Ohio to said District Advisory Council of the Franklin County General Health District. Said sum of money shall be paid by the City of Bexley, Ohio within (30) days after receipt of invoice.

IN WITNESS WHEREOF, the parties to this agreement have hereunto set their hands and seals and have executed this agreement this 31st day of December, 1994.



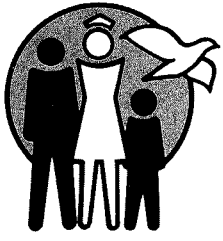

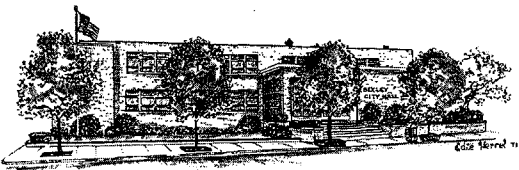
