An Ordinance to grant a variance pursuant to Section 1264.14(c)(2) of the Codified Ordinances for property located at 2651 East Main Street to permit the property which is zoned Office Commercial (OC) to be used for retail service purposes, specifically, an eating place known as Bruegger's Bagel Bakery.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

That Quality Dining, Inc., leasee of the property, has requested a Section 1. variance for property at 2651 East Main Street to allow the use of the property for retail service purposes, specifically, the eating place known as Bruegger's Bagel Bakery.

That the applicant understands and has agreed to comply with Section 2. parking, environmental review and building code requirements.

That the approval of the variance would not have an adverse effect Section 3. on the surrounding properties or neighborhood, would assist in generating a vigorous business climate on Main Street, would allow an appropriate adaptive reuse of this property, and complies with Council's power and authority to grant variances as set forth in Section 1264.14(c)(2).

That the proposed use of the building for retail service is <u>Section 4</u>. compatible with the recognized permitted uses in the Office Commercial Zoning District, produces substantial justice and is not contrary to the public interest.

That this variance is limited to the period of time the building is Section 5. occupied by Bruegger's Bagel Bakery, and the use shall revert to uses permitted under the Office Commercial Zoning District when vacated by Bruegger's Bagel Bakery.

That the application for the variance should be, and it is therefore, Section 6. granted.

That this Ordinance shall go into effect and be in force from and Section 7. after the earliest period allowed by law.


