An Ordinance to grant a variance pursuant to Section 1264.14(c)(2) of the Codified Ordinances for property located at 2570 East Main Street (State Savings), to permit the property which is zoned Community Commercial to be used for an outdoor farmer's market.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

That the Pearl Alley Growers Association has requested a variance Section 1. for property at 2570 East Main Street to allow the use of the property for an outdoor farmers market.

Section 2. That the market will be conducted one day per week for a period of not more than five hours between the hours of 7:30am and 8:00pm during the growing season.

That the market will be limited to members or authorized vendors of Section 3. the Pearl Alley Growers Association.

That the applicant understands and has agreed to comply with Section 4. environmental review and signage requirements.

That the approval of the variance will not have an adverse effect on Section 5. the surrounding properties or neighborhood, would assist in providing a service to residents that is not currently available within the city, would encourage communityoriented shopping, would alleviate hardships imposed on the use of the property and would comply with Council's power and authority to grant variances as set forth in Section 1264.14(c)(2).

Section 6. That the proposed outdoor farmers market is compatible with the recognized permitted uses in the Community Commercial Zoning District, produces substantial justice, and is not contrary to the public interest.

That this variance shall expire on December 31, 1996, unless Section 7. extended by Council.

That the application for the variance should be, and it is therefore, Section 8. granted.

Section 9. That this Ordinance shall go into effect and be in force from and after the earliest period allowed by law.
