An Ordinance to authorize the Mayor and Auditor to enter into a contract with the Ohio Association of Chiefs of Police, Inc. for consulting services in connection with the process for selecting a new Chief of Police, to appropriate \$6,300 from the unencumbered General Fund to fund such contract and to declare an emergency.
BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:
Section 1. That the Mayor and Auditor are hereby authorized and directed to enter into and execute, on behalf of the City, a contract with the Ohio Association of Chiefs of Police, Inc. for consulting services in connection with the process for selecting a new Chief of Police, said contract to be in the form attached hereto and made a part hereof.
Section 2. That \$6,300 is hereby appropriated from the unencumbered General Fund to fund said contract.
Section 3. That this Ordinance is an emergency measure necessary for the immediate preservation of the public peace, health and safety, said emergency being the need to commence with the selection process at the earliest possible date and to fill such position by January 15, 1997, and shall go into effect immediately upon its passage and approval by the Mayor.

AGREEMENT FOR SERVICES WITH CLIENT

OACP ADVISORY SERVICES DIVISION

This AGREEMENT is entered into this 30th day of September 1996, between the Ohio Association of Chiefs of Police, Inc., 6277 Riverside Drive, Dublin, Ohio 43017, hereinafter referred to as OACP, and Mayor David Madison, City of Bexley, Bexley City Hall, 2242 East Main Street, Columbus, Ohio 43209, hereinafter referred to as CLIENT.

Whereas, OACP proposes to provide a service to law enforcement agencies, OACP will serve as administrator. The OACP will select or provide a list of names of Police Management Consultants, hereinafter referred to as CONSULTANT, who will provide needed consulting services directly for the CLIENT. CONSULTANTS are subject to approval by the CLIENT.

ARTICLE I - STATEMENT OF SERVICES

- 1. The CONSULTANTS shall provide professional consulting services to the CLIENT.
- 2. The service to be performed by the CONSULTANTS for the CLIENT shall be to serve as CONSULTANTS in conducting the Pre-Assessment, Candidate Search and Assessment Process for Chief of Police position within the City of Bexley Police Department. The candidate search (Phase II) will include: Developing the position announcement, Special member mailing to law enforcement list of 750, Advertisement in the Columbus Dispatch, (OACP will pay up to \$475.00 of cost incurred.), Screening of applicants, Receiving resumes at the OACP, and Letters to applicants. Chief Wayne I. McCoy will conduct the Pre-Assessment and serve as the LEAD CONSULTANT.

ARTICLE II - PERFORMANCE

- 1. All services to be performed pursuant to Article I of this AGREEMENT shall be conducted with the expectation the Chief of Police will be in position January 15, 1997. A timetable will be developed and agreed upon by Mayor Madison and Chief Wayne McCoy. Upon completion of the Assessment the written final report shall be submitted to the official signing this CHENT AGREEMENT within two weeks after conducting the Assessment Process.
- 2. Each project phase involved in providing the services to be performed pursuant to Article I of this AGREEMENT shall be specified and scheduled by mutual consent of the CLIENT and the LEAD CONSULTANT, Chief Wayne I. McCoy.

ARTICLE III - INDEPENDENT CONTRACTOR

- 1. It is hereby agreed that the CONSULTANTS are independent contractors, and not employees of the OACP.
- 2. In addition, the CLIENT will not hold OACP liable for any act or omission of the CONSULTANTS, except due to OACP's own negligent acts or omissions.

ARTICLE IV - DISCLOSURE

- 1. Except as provided in Article IV, No. 2, it is hereby agreed that the CONSULTANTS and OACP will keep findings, reports, and/or recommendations confidential to the public unless otherwise agreed in writing.
- To the extent reasonably necessary to enable the CONSULTANTS to perform their duties, the OACP may provide clerical and/or typing support to the CONSULTANTS.

ARTICLE V - DELEGATION OF AUTHORITY

1. It is hereby agreed that Mayor David Madison, of the CLIENT jurisdiction is the sole party authorized to direct the work of LEAD CONSULTANT Chief Wayne I McCoy, and to approve Police Management Consultants.

ARTICLE VI - EXPENSES

- 1. The CLIENT agrees to pay the OACP a sum not to exceed \$6,300.00 for conducting the Pre-Assessment (Phase I), Candidate Search (Phase II) and Assessment (Phase III) as described in Article I.
- 2. The CLIENT agrees to forward total payment for services no later than thirty (30) days following receipt of invoice from the OACP.
- It is hereby agreed that the CLIENT will not withhold any money to the OACP for income taxes
 or retirement or for any other purposes, nor will the CONSULTANTS receive any fringe benefits.
- 4. If after the date of completion of the Review Process and after providing the CLIENT the written formal results, the CLIENT requests that a CONSULTANT provide additional service to the CLIENT, then the CLIENT agrees to pay OACP for those services.

ARTICLE VII - CHANGES, NOTIFICATIONS, OR RENEWAL

- This AGREEMENT constitutes the entire agreement between the parties and any changes, modifications, or renewals of this AGREEMENT shall be made and agreed to in writing by both the OACP and the CLIENT.
- 2. It is hereby understood that this AGREEMENT may be terminated prior to the date set forth in Article II, No. 1 by mutual written consent between the OACP and the CLIENT.

ARTICLE VIII - CONSTRUCTION

1. This AGREEMENT shall be construed, interpreted, and the rights of the parties determined in accordance with the laws of the State of Ohio.
