An Ordinance to authorize the Mayor and Auditor to execute an agreement on behalf of the City with the Franklin County District Board of Health for supplemental public health services and to declare an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That the Mayor and Auditor are hereby authorized to execute an agreement on behalf of the City with the Franklin County District Board of Health in the form attached hereto and made a part of this Ordinance.

Section 2. That this Ordinance is an emergency measure necessary for the immediate preservation of the public peace, health and safety, said emergency being the need to assure uninterrupted public health services, and shall go into effect upon its passage and approval by the Mayor.

CONTRACT

BETWEEN THE CITY OF BEXLEY, OHIO AND THE DISTRICT ADVISORY COUNCIL OF THE FRANKLIN COUNTY GENERAL HEALTH DISTRICT.

This contract is made and entered into by and between the City of Bexley, Ohio, a municipal corporation and the District Advisory Council of the Franklin County General Health District.

WITNESSETH

SECTION 1. The Chairperson of the District Advisory Council of the Franklin County General Health District shall, for the consideration hereinafter stated, furnish to the City of Bexley, Ohio, and inhabitants thereof, all such public health services as are furnished by said Council to all villages and townships and the inhabitants thereof, of Franklin County, Ohio. Said services as shall include the following Minimum Public Health Standards for Local Health Departments:

3701-36-05 Health Education
3701-36-06 Communicable Disease Control
3701-36-07 Chronic Disease Control
3701-36-08 Genetic Disease Control
3701-36-09 Primary Care
3701-36-14 Vector Control
3701-36-17 Child Health
3701-36-18 Nutrition Services
3701-36-20 Family Planning
3701-36-21 Substance Abuse
3701-36-22 Disaster Preparedness
3701-36-23 Accident Prevention

SECTION 2. Robert A. Everhart, M.D. will act as Medical Advisor and Nancy I. Pry, R.N. will act as Director of Nursing.

SECTION 3. Whenever any additional service or any new program is planned, approval of the City Council must be secured unless an actual emergency endangering the public health exists. Any program offered as an optional activity must be approved by the City Council. In cases where court action may be necessary in order to secure the public health, the Mayor of the City shall be informed of the legal action proposed by the representatives of the Health Department and shall agree thereto.

The City Attorney of Bexley, Ohio shall be responsible for the litigation of Health Regulations within the corporate limits of said political subdivision.

SECTION 4. Said public health services shall be furnished beginning January 1, 1999 and ending December 31, 1999 provided, however, that either party to this agreement shall have the right to cancel the same upon four months written notice and the parties hereto may, by mutual written agreement, modify the terms of this agreement.

SECTION 5. The Health Department shall render a monthly report to the Health Commissioner of the City of Bexley on all services directly rendered to the citizens of Bexley. Such a report shall describe the type of service, where and for whom the service was rendered, and the number of cases, visits or other appropriate work units.

SECTION 6. The City of Bexley, Ohio shall pay to the Franklin County General Health District for said public health services furnished the City of Bexley, Ohio and the inhabitants thereof, such sum in the amount of Five Thousand Dollars (\$5,000.00) to be invoiced annually on the first day of January, 1999.

SECTION 7. Said sum or sums of money shall be paid by the said City of Bexley, Ohio to said District Advisory Council of the Franklin County General Health District. Said sum of money shall be paid by the City of Bexley, Ohio within thirty (30) days after receipt of said invoice.

SECTION 8. This contract is approved by a majority of the members of the City of Bexley Board of Health, pursuant to the provisions of Resolution/Ordinance dated _____ and City of Bexley Ordinance _____ dated _____.

SECTION 9. The City of Bexley, Ohio has determined that the District Advisory Council of the Franklin County General Health District is organized and equipped to adequately provide the service which is the subject of this contract. Pursuant to Ohio Revised Code section 3709.08, the Franklin County Health Department shall have all the powers and perform all the duties required of the board of health of city health district within the jurisdiction of the City of Bexley.
