Section 7. That this ordinance shall go into effect and be in force from and after the earliest period allowed by law.

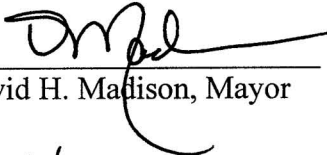
