CONTRACT

BETWEEN THE CITY OF BEXLEY, OHIO, AND DAVID S. KESSLER, DBA DUBLIN MANAGEMENT GROUP LIMITED, HEREINAFTER REFERRED TO AS DAVID S. KESSLER

WITNESSETH

Section 1. David S. Kessler shall, for the consideration hereinafter stated, furnish to the City of Bexley, Ohio, human resource consultant services as requested by the City.

Section 2. Said services shall be furnished for a period beginning January 1, 2000, and remaining in force until December 31, 2000, provided, however, that either party to this agreement shall have the right to cancel the same upon three (3) months written notice.

Section 3. The City of Bexley, Ohio, shall pay David S. Kessler for said services furnished to the City of Bexley, Ohio, thereof, \$100.00 per hour.

Section 4. Said sum or sums of money shall be paid by the City of Bexley, Ohio, to David S. Kessler monthly and shall be paid within thirty (30) days after receipt of a statement.
