An Ordinance to grant a lot split for Lot No. 1 of Block 8 of the Bullitt Park Amended Subdivision, creating two separate lots.

Whereas, Lot No. 1 of Block 8 of the Bullitt Park Amended Subdivision was previously split into two lots in the year 1968, and

Whereas, the west portion of Lot No. 1 became known as 2291 Clifton Avenue and a residential structure was constructed on the site, and

Whereas, the second parcel was maintained as a separate lot without separate address or structures, and

Whereas, Peter and Edith Korda purchased both lots in the year 2001 and combined the lots, recreating the original lot with the intent of building a residential structure on the recreated lot, and

Whereas, the Kordas now find that they are unable to go forward with their project as proposed and wish to return the property into the two lots as created in the year 1968, NOW THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

<u>Section 1.</u> That Lot No. 1 of Block 8 of the Bullitt Park Amended Subdivision should be spit into the two lots as previously approved in the year 1968 and as further described by Exhibit A (a legal description dated June 15, 2001) and a survey dated September 8, 1993.

<u>Section 2.</u> That this Ordinance shall take effect and be in force at the earliest period allowed by law.
