An Ordinance to grant a lot split for Lot 5 Parkview Subdivision, by splitting off a 0.125 acre portion of the south half of said Lot 5, and to grant variances pursuant to Section 1264.14(c)(1) of the Zoning Code for the new lot so created from the area, width and depth requirements of the R-3 District at Section 1252.03(c) of the Zoning Code and a variance for the remainder lot with the street address 375 South Parkview Avenue from the area requirement of the R-3 District at Section 1252.03(c) of the Zoning Code.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That a 0.125 acre portion of the south half of Lot 5 Parkview Subdivision be split off from Lot 5 as more particularly described in Exhibit A consisting of a legal description dated December 4, 2001 of the new 0.125 acre lot to be so created and in Exhibit B consisting of a survey dated December 3, 2001.

Section 2. That the new lot created pursuant to Section 1 hereof, which has an area of 5,453 square feet and is 66.5 feet wide and 82 feet deep, is hereby granted variances from the minimum area requirement of 14,400 square feet, the minimum width requirement of 90 feet and minimum depth requirement of 160 feet of the R-3 District at Section 1252.03(c) of the Zoning Code.

Section 3. That the remainder lot with the street address 375 South Parkview Avenue, which has an area of 11,123.45, is hereby granted a variance from the minimum area requirement of 14,400 square feet of the R-3 District at Section 1252.03(c) of the Zoning Code.

Section 4. That this Ordinance shall take effect and be in force at the earliest period allowed by law.




