A resolution to declare that the amount of taxes that may be raised within the ten mill limitation will be insufficient to provide for the necessary requirements of the City and that it is necessary to levy a tax in excess of that limitation, to authorize submission of a 2.5 mill levy for street and similar improvements pursuant to Sections 5705.19(PP) of the Ohio Revised Code, which levy shall be for a continuing period of time, to the electors of the City at the general election to be held on November 5, 2002, to authorize and direct the Clerk of Council to certify this Resolution to the Board of Elections of Franklin County, Ohio.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That this Council hereby declares that the amount of taxes that may be raised within the ten mill limitation will be insufficient to provide for the necessary requirements of the City and that it is necessary to levy a tax (the "Levy") in excess of that limitation in the amount of 2.5 mills for the purpose of constructing, reconstructing, resurfacing, and repairing streets, alleys, sidewalks and other similar improvements pursuant to Section 5705.19(PP) of the Ohio Revised Code.

Section 2. That this Council hereby declares its intention to submit the Levy to the electors of the City at the general election to be held on November 5, 2002, which levy shall be for a continuing period of time and shall be placed on the duplicate for the current year (tax year 2002, for collection beginning 2003).

Section 3. That, following its passage by Council, the Clerk of Council is hereby authorized and directed to certify to, and file with, the Board of Elections of Franklin County, Ohio, a copy of this Resolution on or before August 22, 2002.

Section 4. That this resolution shall take effect immediately upon its passage and approval by the Mayor, as provided by law.
