ORDINANCE 64-12

An Ordinance to establish rates for all salaried, part time and casual employees of the City of Bexley, effective as of January 1, 2013.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY,

<u>Section 1.</u> That elected officials of the City of Bexley are to be paid in a manner prescribed by the Charter and Ordinances.

<u>Section 2.</u> That all Schedule 1 employees are paid an annual salary calculated on the basis of an hourly rate multiplied by a 2080 hour work schedule per year as follows:
