A RESOLUTION RESCINDING RESOLUTION NO. 6-05 AND WITHDRAWING AUTHORIZATION TO SUBMIT THE 1.7 MILLS REPLACEMENT LEVY APPROVED THEREBY TO THE ELECTORS OF THE CITY AT THE MAY 3, 2005 ELECTION.

WHEREAS, on February 8, 2005, the City Council (the "Council") passed Resolution No. 6-05 declaring the necessity, for the purpose of current operating expenses of the City of Bexley (the "City"), to replace all of a tax in excess of the ten-mill limitation in the amount of one and seven tenths (1.7) mills for each one dollar of valuation (the "Replacement Levy") and certifying said levy to the Franklin County Board of Elections for submission to the electors of the City at the May 3, 2005 election; and

WHEREAS, the Council has determined to defer submission of a renewal or replacement levy to the electors of the City at this time and to withdraw authorization to submit the Replacement Levy at the May 3, 2005 election;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Bexley, Franklin County, Ohio, two-thirds of all of the members elected thereto concurring, that:

Section 1. Resolution No. 6-05 is hereby rescinded and authorization to submit the Replacement Levy to the electors of the City at the election to be held on May 3, 2005 is hereby withdrawn.

Section 2. The Clerk of Council of the Council is hereby directed and shall promptly certify to the Franklin County Board of Elections a copy of this Resolution.




