That the Mayor and Auditor be, and each of them hereby is, authorized and directed to execute an agreement, a copy of which is attached and made a part of this Ordinance with William Minckler to provide Information Systems consulting services, *subject to Mr. Minckler's resignation from the Technology Commission.*

Section 2. That this Ordinance shall go into effect and be in force from and after the earliest period allowed by law.

**CONTRACT**

BETWEEN THE CITY OF BEXLEY, OHIO, AND WILLIAM MINCKLER.

WITNESSETH


Section 1. William Minckler, shall, for the consideration hereinafter stated, furnish to the City of Bexley, Ohio, and the inhabitants thereof, Information Systems consulting services as requested by the City.

Section 2. Said services shall be furnished for a period beginning March 1, 2005 and remaining in force until December 31, 2005, provided, however, that either party to this agreement shall have the right to cancel the same upon three (3) months written notice.

Section 3. The City of Bexley, Ohio, shall pay William Minckler for said services furnished to the City of Bexley, Ohio, and the inhabitants thereof, \$65.00 per hour.

Section 4. Said sum or sums of money shall be paid by the City of Bexley, Ohio, to William Minckler monthly and shall be paid within thirty (30) days after receipt of a statement.

IN WITNESS WHEREOF, the parties to this agreement have hereunto set their hands and have executed this agreement this 9<sup>th</sup> day of March, 2005.




