ORDINANCE NO. 3^3 - 05

An Ordinance to release certain easements retained by the City in two alleys vacated by Ordinance No. 17-63 and Ordinance No. 55-42, to authorize the Mayor and Auditor to execute a Release of Easements and to declare an emergency.

WHEREAS, Ordinance No. 17-63 vacated the first alley east of Parkview Avenue from Main Street north to the south line of Lot 3 of Powell's Subdivision, reserving to the City certain easements; and

WHEREAS, Ordinance No. 55-42 vacated the first alley north of Main Street to the first alley east of Parkview Avenue, reserving to the City certain easements; and

WHEREAS, said easements are not required by the City and interfere with development of the property as approved by the Main Street Redevelopment Commission;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That the City hereby releases all easements reserved for the benefit of the City and the public by Ordinance No. 17-63 and Ordinance No. 55-42; provided that such release shall not affect the right of any public utilities or other private parties that have an interest in the vacated alleys.

Section 2. That the Mayor and Auditor are hereby authorized and directed to execute, on behalf of the City, a Release of Easements in a form approved by the City Attorney.

Section 3. That this Ordinance is an emergency measure necessary for the immediate preservation of the public health, safety or welfare, said emergency being the need to permit the development of the property as approved by the Main Street Redevelopment Commission to proceed at the earliest possible date, and shall be in full force and effect from and after its passage and approval by the Mayor.
