An Ordinance to authorize a contract for architectural consulting services as required by the Board of Zoning Appeals.


**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:**

**WITNESSETH**


Section 1. Karen Bokor, shall, for the consideration hereinafter stated, furnish to the City of Bexley, Ohio, and the inhabitants thereof, architectural consulting services as requested by the City.

Section 2. Said services shall be furnished for a period beginning January 1, 2005 and remaining in force until December 31, 2005, provided, however, that either party to this agreement shall have the right to cancel the same upon three (3) months written notice.

Section 3. The City of Bexley, Ohio, shall pay Karen Bokor for said services furnished to the City of Bexley, Ohio, and the inhabitants thereof, \$60.00 per hour.






