ORDINANCE NO 78-05

An Ordinance to grant a Councilmatic Variance to permit certain uses of an accessory structure on the property at 400 N. Drexel Avenue in the City of Bexley, Ohio.

Whereas, on July 19th 2005, the applicant has applied to the Bexley Board of Zoning Appeals to grant a variance to permit the construction of an addition to an existing bath in an accessory structure, on the property known as 400 N. Drexel Avenue, Bexley, Ohio; and

Whereas, the present owners of said property, Joseph and Denise Bronson wish to install a full bathroom in said accessory structure; and

Whereas, Bexley Code Section 1260.11(b) prohibits the use of accessory structures for a dwelling unit, and

NOW THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That a Councilmatic Variance is hereby granted to permit the use of the proposed accessory structure on the property known as 400 N. Drexel Avenue, Bexley, Ohio, as living space, said space being a bathroom, subject to the following conditions:

conditions:

(a) There shall be no expansion of the existing accessory structure beyond what is approved by the Board of Zoning Appeals on Fifty 19th, 2005; and as further approved with this Ordinance.

- (b) The accessory structure shall at no time be utilized by persons other than members and guests of the family of the owner of the property.
- (c) The accessory structure shall at no time be occupied full time nor shall it be utilized as a dwelling unit.
- (d) Should the accessory structure be damaged by fire, explosion, flood, riot, or act of God, the use may be continued as before any such calamity provided the structure has not been destroyed to the extent of more than ninety percent of the replacement cost at the time of destruction, and provided such reconstruction is started within one year of such calamity and is continued in a reasonable manner until completed. If more than ninety percent of the replacement cost at the time of destruction of the accessory structure occurs any time in the future by fire, explosion, flood, riot, or act of God, continued use of the structure will require a special permit at the discretion of Bexley City Council.




