The purpose of the amendments and additions to Section 648.10 is to add a day-time curfew provision for students who have been suspended or expelled from school, to clarify the truancy law for minor, and to declare an emergency.
- 15-06** An Ordinance to withdraw the Councilmatic Variance granted by Ordinance No. 45-05 permitting construction of stone piers on the property at 195 South Parkview Avenue.
- 16-06** An Ordinance to authorize the Mayor and the Auditor to execute a contract with David R. Ahlum for the purpose of providing consulting arborist services.
- 17-06** An Ordinance to appropriate \$30,000 from Capital Improvements Fund for the purpose purchasing electronic data processing equipment and software for city.
